SPEAKING ORDER**

No. 13/09-2024 PGT-I (1)

Whereas, Sh. Bijender Singh has filed CWP No. 939 of 2024 titled as Bijender Singh vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondent-Department to promote the petitioner to the post of Post Graduate Teacher (PGT) English w.e.f. 13.04.2022, the date of promotion of the junior TGTs with all the consequential benefits.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 16.01.2024 with following orders:-

*“.....In view thereof, without commenting anything on the merits of the case, the petition stands disposed of directing the second respondent/ Director, Secondary Education, Haryana, to decide the pending representation of the petitioner, dated 7.9.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving certified copy of this order. In case the petitioner is found entitled to be promoted, necessary order to that effect will be passed within four weeks thereafter.*

In compliance of above said order, the representation dated 07.09.2023 of Sh. Bijender Singh, TGT English has been duly examined and it is found that he was initially appointed as PRT/JBT on 13.08.2008 and later on, promoted to the post of TGT/Master (English) on 15.01.2020.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualifications for promotion of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) are as under:-

**By promotion:-**

- (i) M.A. English with at least 50% marks and B.Ed. from recognized university; AND
- (ii) 2 years teaching experience as TGT English; or  
Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.

Whereas, Sh. Bijender Singh joined as TGT English on 01.02.2020. The cut off date for applying for the promotion by sending the cases through proper channel was 31.12.2020 and promotion orders were issued on 08.01.2021. Thereafter, again promotion cases were invited and cut off date for applying for the promotion by sending the cases through proper channel was 30.11.2021

and promotion orders were issued on 13.04.2022. The meeting of Departmental Promotion Committee for scrutiny of promotion cases was held on 12.01.2022. The meeting was held within 2 months from cut off date, so there is no delay on behalf of the department. On the day of DPC, petitioner did not possess the mandatory 2 years teaching experience as TGT English as required under Haryana State Education School Cadre (Group- B) Service Rules, 2012 and hence, found not eligible for promotion to the post of PGT (English). Action against juniors of the petitioner who were inadvertently promoted to the post of PGTs is being taken by giving show cause notice to them.

In view of the facts mentioned above, the claim of Sh. Bijender Singh is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.

Sanction is hereby accorded to grant a sum of ₹10,86,960/- (Rs. Ten Lacs Eight Six Thousand Nine Hundred Sixty only) as Medical Advance to Smt Seema Bishnoi [079644] PGT English, Government Senior Secondary School, Neoli Khurd [4005] (Hisar) to meet expenditure in connection with treatment of her spouse i.e. Shri Vijender Kumar Medanta Hospital, Gurugram (On Panel) in the light of Rule 10 of Health Department Policy dated 06.05.2005 by giving in relaxation of Punjab/ Haryana services Medical Attendants Rule, 1940 subject to the following conditions:-

1. The Govt. will bear the expenditure spent on indoor treatment medicines/Hospital charges only.
2. The amount of medical advance will be adjusted according to the Medical rules. The adjustment of amount will have to be utilized within three months failing which penal interest will be charged as per instruction dated 06.05.2005 of Health Department
3. The advance payment should not be considered that the Medical Bill has been granted. It will be seen on examining the case whether the amount will be adjusted or it is to be recovered.
4. The adhoc employee/officer will not given Medical advance if an official /employee is temporary then he will have to give surety of permanent officer/ employee. A retired officer/official will be required to furnish surety of two permanent officers/official for getting the medical advance.
5. The payment of Medical Advance ₹10,86,960/- Rs. Ten Lacs Eight Six Thousand Nine Hundred Sixty only) shall be made within 15 days before the date of operation.
6. Advance is allowed subject to the condition that the admissible bill amount will not be less than the advance amount.
