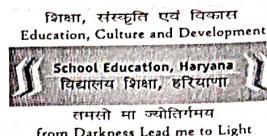

In compliance of Hon'ble High Court order dated 22.11.2022 passed in CWP No. 26652 of 2022 titled as Sohan Lal vs. State of Haryana and others, Sh Sohan Lal [081529], Social Studies Master, Government Middle School Jateri [6213], Yamunanagar now working in Government High School Mand Kheri [228], Yamunanagar is hereby promoted as **PGT History w.e.f. 13.04.2022 (Notionally)** i.e. the date from his/her juniors were promoted to the post of PGT History in the Scheduled-I of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600-1,51,100/- plus usual allowances as admissible from time to time and posted temporarily in the school mentioned against his/her name as under:-

Terms & Conditions:-

1. The benefit of notional pay fixation and seniority will be admissible w.e.f. **13.04.2022** from the date when his/her juniors have been promoted and actual financial benefits will be admissible to him from the date when he/she joins duty as **PGT History**.
2. If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending subsequently, the said incumbents (s) shall be reverted without issuing any notice.
3. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
4. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government.
5. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.05.2006.
6. If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.

7. These promotion orders are based on provisional seniority list and without prejudice to the right of the seniors to be considered if they opt for promotion as **PGT (History)** provided those seniors are found eligible for the post.
8. In case the degree of a teacher is found not to be from a recognized University having no statutory authority/ jurisdiction in regard to award of such degree, the promotion shall be cancelled forthwith and the teachers so promoted shall be liable for strict disciplinary action.
9. The teachers in the provisional seniority list who are senior to the teachers whose documents have been found in order and eligible are being promoted and, posts have been reserved for them pending determination of their eligibility at a later date.
10. Inter se seniority based on the feeder cadre shall be the determining factor in the PGT cadre. In other words if a senior employee in the C&V cadre is found eligible at a later date and vacancy in respect of his/her is occupied by a junior employee then the Junior employee shall have to be reverted back so that such senior employee may get his/her due promotion.

Whereas, Smt. Jyoti had filed the CWP No. 14033 of 2024 titled as Jyoti Vs. State of Haryana & another in the Hon'ble Punjab & Haryana High Court, praying therein to direct the respondents to give appointment to the petitioner to the post of Post Graduate Teachers (Physical Education).

The above mentioned writ petition came up for adjudication on 01.07.2024 and the Hon'ble High Court disposed of the same vide order dated 01.07.2024. The operative part of the same is as under: -

".....In view thereof, without going into the merits of the case, the petition is disposed of with liberty to the petitioner to file a representation before Director of Secondary Education within two weeks from today. In case any such representation is filed by the petitioner, the same shall be decided by passing a speaking order thereupon, within a period of six weeks of receiving the representation."

In compliance of the above said order dated 01.07.2024 passed by the Hon'ble High Court, the representation dated 11.07.2024 has been examined and thereupon, it has been found that the candidature of the petitioner was not considered by the Department on the ground that the petitioner has obtained the requisite qualification via distance mode from the deemed to be university namely Institute of Advanced Studies In Education University, Sardarshahar, Rajasthan.

Whereas, as per Haryana State Education School Cadre (Group - B) Service Rules, 2012, essential qualification must be from a recognized university and it has been specifically mentioned in Rule No. 2 (h) of the 2012 Rules that only the recognized universities were considered for the purpose of appointment/promotion to the post of PGT. The relevant portion of the Rule is reproduced here as under:-

2 (h) Recognized University

- (i) *any university incorporated by Law in India; or*
- (ii) *any other university which is declared by the Government to be a recognized university for the purpose of these rules;*

Whereas Institute of Advanced Studies in Education University, Sardarshahar, Rajasthan is not competent to run the distance education programme beyond their territorial jurisdiction without the permission of State Govt. and UGC. Whereas this University did not take permission from the State Government and UGC before opening study center to run distance education

/s/

programme. In absence of the permission of UGC and State Government wherein study centers are located, the degrees obtained from such study centers by the candidates are not legal and such candidates are not eligible for appointment/promotion as PGT in Haryana Govt. Services.

Whereas, similar candidates seeking appointment had earlier filed a CWP No. 7626 of 2015 titled as Gurmail Kaur & Ors. Vs State Of Haryana & Ors. The Hon'ble Punjab and Haryana High Court allowed the writ petition vide order dated 27.05.2015.

Now the matter is pending in the Hon'ble Supreme Court in SLP No.017134/2021 titled as State of Haryana and others vs. Gurmail Kaur and others. Which is fixed for 22.10.2024 (tentative).

Whereas, similar situated candidates pertaining to appointment have filed CWP No. 22528 of 2021, which was allowed by Hon'ble High Court on 29.08.2022. Thereafter, the department has filed the Latent Patent Appeal No. 98 of 2023 before the Division Bench in the Hon'ble High Court against the said order of Single Bench dated 29.08.2022 & the matter is now pending for adjudication on 11.11.2024 wherein, the stay has already been granted by the Hon'ble Division Bench. The operative part of the order dated 02.02.2023 is reproduced here as under:-

".....Granting time to the respondent to file reply to the stay application, this Court in the meanwhile, by way an ad-interim measure, stay operation of the impugned judgment passed by the learned Single Judge."

Whereas, at this stage the issue w.r.t. deemed universities is *sub-judice* before the Hon'ble Apex Court as well as before the Hon'ble High Court and there is an interim order passed by the Hon'ble High Court dated 02.02.2023 as referred *supra*. Therefore, at this stage the department is *in-capacious* to proceed with the claim of the petitioner demanded through re-representation dated 11.07.2024.

Keeping in view of the facts mentioned above & documents on record and orders of Hon'ble Division Bench, the claim raised by Smt. Jyoti in her representation dated 11.07.2024 is not tenable at this stage & hereby rejected being devoid of merits.

I order accordingly.

Permission is hereby granted to **Sh. Punam, PGT Hindi, Govt. Sr. Sec. School, Kussar (Sirsa)** to change of option from fixed medical reimbursement to outdoor reimbursement for treatment of chronic diseases w.e.f. **10.07.2024** in terms of Haryana Government instructions issued time to time on the following conditions:-

1. That he/she will not be entitled to the fixed medical allowances w.e.f. the date of change of option i.e. 10.07.2024. The fixed medical allowance already received w.e.f. 10.07.2024 will have to be deposited in Government treasury.
2. The reimbursement will be made only for chronic diseases declared by Haryana Govt. from time to time.
3. That he/she will not be entitled for fixed medical allowance as long as he/she avails open medical allowance facility.
4. That the medical option has been changed since the pensioner/employee/employee's dependent family member is suffering from chronic disease. The certificate in this regard should be issued by the competent authority defined in the Rules.
5. The Medical Certificates is to be reviewed / renewed after a period of Five years or before date of its expiry whichever is earlier otherwise his/her medical option will be changed from open to fixed automatically.

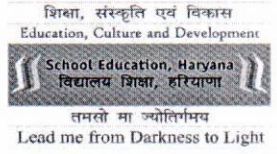


