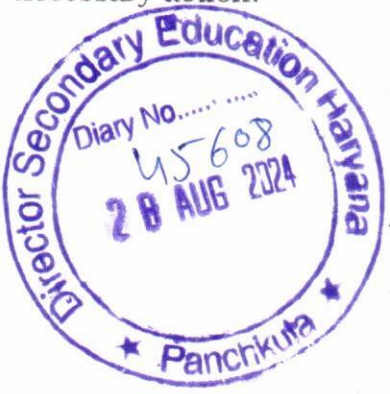

महोदय/महोदया,

उपर्युक्त विषय पर मुझे आपको यह कहने के निर्देश हुए हैं कि हरियाणा विधानसभा चुनाव, 2024 का कार्य इस समय चर्म सीमा पर है। जैसा कि आपको विदित है कि चुनाव एक जटिल तथा समयबद्ध प्रक्रिया है। भारत निर्वाचन आयोग के पत्र क्रमांक ECI/PN/128/2024, दिनांक 16.08.2024 के द्वारा हरियाणा विधान सभा आम चुनाव, 2024 की घोषणा की जा चुकी है।

अतः यह आवश्यक है कि चुनाव सम्बन्धी विभिन्न स्टैजिज पर किए जाने वाले सभी कार्यों को ध्यानपूर्वक व सुचारु रूप से निर्धारित समय में सम्पन्न किया जाए। चुनाव के प्रोग्राम में कुछ विषय कानूनी प्रावधानों पर आधारित हैं, जिनका निर्धारित समय के अन्दर-2 पालन करना कानूनी रूप से अनिवार्य है।

इसके अतिरिक्त चुनाव सम्बन्धी विषय में किसी प्रकार की ढील, चुनाव कार्यक्रम को अस्त-व्यस्त कर देगी, जिसके गम्भीर परिणाम हो सकते हैं। ऐसी स्थिति उत्पन्न न होने देने के लिए यह अति आवश्यक है कि हरियाणा राज्य के सभी विभागों द्वारा निर्वाचन विभाग को हर प्रकार से पूर्ण तथा तत्परता से सहयोग दिया जाए।

अतः आपसे अनुरोध है कि चुनाव विभाग द्वारा आपको भेजे जाने वाले सभी पत्रों को प्राथमिकता दी जाए तथा जब भी इस विभाग की ओर से किसी प्रकार की सूचना, आपसे निर्धारित समय में मांगी जाए तो आप कृपया यह सुनिश्चित करें कि वह सूचना हर मामले में, वांछित अवधि में इस विभाग को अवश्यमेव पहुंच जाए। इसके अतिरिक्त आप राज्य में अपने अधीन सभी कार्यालय अध्यक्षों को निर्देश जारी करने का कष्ट करें कि वह सभी जिला निर्वाचन अधिकारियों को पूर्ण सहयोग प्रदान करें। विभाग को पूर्ण विश्वास है कि चुनाव कार्य में जब कभी भी आपके व्यक्तिगत सहायता की आवश्यकता होगी, तो उस समय भी आप अपना सहयोग देंगे और चुनाव कार्य में भी यथा समभव सहायता करेंगे।

Provided that where at an election held in accordance with the system of 'proportional' representation by means of a transferable vote, a candidate is not elected, the deposit made by him shall be forfeited if he does not get a one-sixth of the number of votes prescribed in this behalf as sufficient to secure the return of a candidate.

(3) Notwithstanding anything in sub-sections (2), (3) and (4),—

(a) if at a general election, the candidate is a contesting candidate in more than one parliamentary constituency or in more than one assembly constituency, not more than one of the deposits shall be returned, and the others forfeited.

(b) if the candidate is a contesting candidate at an election in more than one council constituency or election in a council constituency and at an election by the members of the State Legislative Assembly seats in the Legislative Council, not more than one of the deposits shall be returned, and the others shall be forfeited.

159. Staff of certain authorities to be made available for election work.—(1) The authorities specified in section (2) shall, when so requested by a Regional Commissioner appointed under clause (4) of article 324 or the Electoral Officer of the State, make available to any returning officer such staff as may be necessary for the performance of any duties in connection with an election.

(2) The following shall be the authorities for the purpose of sub-section (1), namely:—

(i) every local authority;

(ii) every university established or incorporated by or under a Central, Provincial or State Act;

(iii) a Government company as defined in section 617 of the Companies Act, 1956 (1 of 1956);

(iv) any other institution, concern or undertaking which is established by or under a Central, Provincial or State Act or which is controlled, or financed wholly or substantially by funds provided, directly or indirectly, by the Central Government or a State Government.

160. Requisitioning of premises, vehicles, etc., for election purposes.—(1) If it appears to the Government that in connection with an election held within the State—

(a) any premises are needed or are likely to be needed for the purpose of being used as a polling station or storage of ballot boxes after a poll has been taken, or

(b) any vehicle, vessel or animal is needed or is likely to be needed for the purpose of transport of ballot boxes from any polling station, or transport of members of the police force for maintaining order during the conduct of an election, or transport of any officer or other person for performance of any duties in connection with such election,

the Government may by order in writing requisition such premises, or such vehicle, vessel or animal, as the case may be, and may make such further orders as may appear to it to be necessary or expedient in connection with the requisitioning:

Provided that no vehicle, vessel or animal which is being lawfully used by a candidate or his agent for any purpose connected with the election of such candidate shall be requisitioned under this sub-section until the completion of the poll at such election.

(2) The requisition shall be effected by an order in writing addressed to the person deemed by the Government to be the owner or person in possession of the property, and such order shall be served in the prescribed manner on the person to whom it is addressed.

(3) Whenever any property is requisitioned under sub-section (1), the period of such requisition shall not exceed the period for which such property is required for any of the purposes mentioned in that sub-section.
