Whereas, Sh. Pawan Singh and others have filed present Civil Writ Petition No. 6187 of 2024 titled as Pawan Singh and others vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein to direct the respondents to consider and decide the representations and legal notice submitted by the petitioners regarding correction of their seniority number in the seniority list dated 08.07.2019 and further, consider the cases of the petitioners for promotion in-lieu of letter dated 09.06.2023.

The Hon'ble Punjab and Haryana High Court disposed of said petition on dated 15.03.2024 with the following orders:-

***".....the pending legal notice, dated 16.11.2023, shall be decided by respondent No. 2/Director Secondary Education, by passing a speaking order in accordance with law, within a period of three months.***

***In view of the statement made by learned state counsel, learned counsel for the petitioners has no objection to the petition being disposed of in terms thereof."***

Whereas, in compliance of said order, the representation dated 16.11.2023 of Sh. Pawan Singh and others, has been examined and it is found that the incumbents were initially appointed as science masters/mistress. Lateron, they were promoted as PGT/Lecturer from November, 2008 to July, 2009. The petitioners have claimed that their seniority be refixed w.r.t. English Lecturers who were promoted vide order No. 15/351-2006 HRL (2) dated 21.07.2009 and PGT Hindi who were appointed vide No. 6/18-2008 HRL (4) dated 07.01.2009.

Whereas, the department had issued the seniority list of PGT Cadre in 2014 which was rectified vide seniority list dated 08.07.2019. However, many representations were pending in the department to re-fix /rectify the seniority on various grounds. Thereafter, the department published rectified tentative seniority list of PGTs on 05.08.2024 and objections were invited from the stakeholders. On the basis of objections/representations received from the stakeholders and after resolving all the objections in the tentative seniority list, the department issued Provisional Seniority List on 04.09.2024 as per the prevailing rules/instructions/policy.

Whereas, Lecturers in English were promoted w.e.f. 25.10.2007 vide order No. 15/1351-2006 HRL (2) dated 21.07.2009. Furthermore, recommendations of various subjects including PGT Hindi were received against Advt. No. 06/2006 vide recommendation No.

112



HSSC/Confid./Recomm./2008/3044-3045 dated 15.10.2008 and appointment were offered against these recommendations from October to December 2008.

Whereas, the Department has decided vide memo No. 13/6-2015 PGT-II (3) dated 05.04.2017 that seniority under same advertisement for different subjects shall be fixed as given below:-


*In this regard it is important to note that, in case of any direct recruitment, where the recruitment process was initiated through a common advertisement issued by the recruiting agency for all subjects in a single date, than all lists of recommendation, originated from such integrated recruitment process, regardless of the date of recommendation or joining, have been allocated a common place in the inter se seniority prepared hereinabove. A single integrated recruitment process has been treated as single integrated recruitment notwithstanding any difference in the date of recommendation/date of appointment order/date of joining. It is further important to note that, to devise inter se seniority the rational of inter se merit has been derived by keeping candidates of same merits of different subjects in one pocket. It is necessarily means that a single pocket has a unique merit. The inter se merit in single pocket has been decided by the age criteria by giving highest seniority to the candidate of highest age so on and so forth.*

So, in view of this, the seniority for these recommended PGTs including PGT Hindi was fixed w.e.f. 15.10.2008 i.e. the date of recommendation. On the other hand, the petitioners were promoted vide order No. 15/44-2008 HRL (3) dated 05.11.2008 and order No. 15/50-2008 HRL (3) dated 24.12.2008 so these petitioners have been placed in the seniority list as on 04.09.2024 below the PGT/Lecturer English, who were promoted w.e.f. 25.10.2007 and also below the PGT Hindi who were directly appointed against Advertisement No. 06/2006.

Keeping in view the facts enunciated above and documents on record, it is observed that seniority of the incumbents has already been fixed by the department as per the existing rules and the incumbents cannot be entitled for the re-fixation of their seniority number as prayed in the legal notice dated 16.11.2023 submitted by them.

Therefore, the claim of Sh. Pawan Singh and others in their legal notice dated 16.11.2023 regarding necessary corrections in the seniority list of Post Graduate Teachers is not tenable at this stage & hereby rejected being devoid of merits.

It is ordered accordingly.

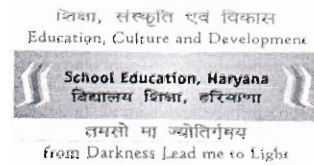

- relevant service rules and instructions of the State Government issued from time to time later on.
