

will be done through the Portal itself as per the selection criteria. The copy of **selection criteria for students & teachers and user manual for handling the portal is enclosed** herewith for detailed information.

The guidelines regarding registering the students and teachers on the Portal are as under:-

1. All the Principals/School Heads of PM Shri Schools will open the Portal by way of using 'School MIS LOGIN ID' and PASSWORD and upload the entries of students and teachers pertaining to their schools on the portal.
2. The **PP size photo** of student/teacher will be uploaded on the portal in jpg format with **maximum size to 200 KB**.
3. The other **documents**, as required as per the selection criteria, like-certificates of DMC/position/participation etc. will be uploaded on the portal in pdf format with **maximum size to 1 MB**.
4. The School Head can make any correction/amendment (with regard to Students only) at any time as per their requirement till the portal is open.
5. The **APCs (YEC & PM SHRI)** and the **District Coordinators (Youth & Eco Clubs) [list enclosed]** will coordinate with the Principals of PM SHRI Govt. schools pertaining to their district and ensure that **minimum 10 Boys, 10 Girls, 1 Male Teacher and 1 Female Teacher** may be registered from each of the 124 PM SHRI Govt. Schools of 1st Phase and **minimum 20 Boys, 20 Girls, 2 Male Teachers and 2 Female Teachers** from each of the 111 PM SHRI Govt. Schools of 2nd Phase accordingly.
6. The consent of parents, in the enclosed format, must be taken from the parents of the students who are willing to apply for any of the above mentioned camp, before registration.
7. The consent of parents and Medical Fitness Certificate w.r.t. the selected candidates, will be produced at the time of reporting in the camp.
8. The list of selected students and escort teachers, event wise, will be shared with the Principals of PM SHRI Govt. schools along with the detailed SOP/instructions regarding schedule of journey and camps, place of reporting, activities, material to be brought, Do's & Don'ts etc.


