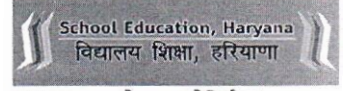

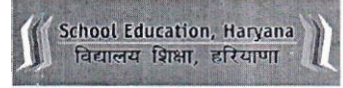

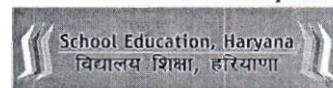

Order No.: 13/98-2016 PGT-II (9)

Dated, Panchkula, the 2.8.2024

Sh. Rajesh Kumar and others filed a Civil Writ Petition No. 13754 of 2016 titled as Rajesh Kumar and others Vs. State of Haryana and others in the Hon'ble Punjab and Haryana High Court. The above mentioned CWP has been filed for direction to consider the claim of the petitioners for promotion as PGT Sanskrit from the date the candidates junior to the petitioners have been promoted i.e. 06.05.2016.

This Civil Writ Petition was disposed of on 15.07.2016 by the Hon'ble High Court with the following directions:-

"Pleadings on record would show that the petitioners were appointed as T.G.T, Sanskrit on regular basis on different dates between the years 1992 to 2000.

Promotion from the post of T.G.T, Sanskrit is to the post of P.G.T., Sanskrit. The conditions of service of the post of P.G.T, Sanskrit would be governed by statutory rules namely the Haryana State Education School Cadre (Group B) Service Rules, 2012. Under the Rules 67% posts of P.G.T., Sanskrit are to be filled up by direct recruitment and 33% by way of promotion from amongst T.G.T., Sanskrit/Sanskrit Teachers.

Precise grievance raised by the petitioner in the instant writ petition is that inspite of being eligible for promotion to the post of P.G.T., Sanskrit under the statutory rules governing the post, yet, they have not been promoted and a number of persons junior to them have stolen a march and have been promoted as P.G.T., Sanskrit. In support of such contention learned senior counsel would advert to the promotion order dated 6.5.2016 appended and placed on record at Annexure P-5. Prayer is for considering the claim of the petitioners for promotion to the post of P.G.T., Sanskrit from the date their juniors have been so promoted.

In view of the facts and circumstances noticed herein above and without making any observations on merits,

passing a speaking order within a period of four months from the date of receipt of a certified copy of this order."

In compliance of the order of the Hon'ble High Court, an opportunity of personal hearing has been granted to the petitioners on 02.08.2024 at 11:00 AM. After hearing the present petitioners and examination of records, it has been found that Department vide letter dated 25.03.2016 invited the cases for the promotion for the post of PGT Sanskrit and promotions were made on 06.05.2016 vide order No.15/18-2016 PGT-II (3) dated 06.05.2016. The rules for the promotion prevalent at that time were Haryana State Education School Cadre (Group-B) Rules, 2012 dated 11.04.2012. As per these rules, qualifications for promotion to the post of PGT Sanskrit were as given below:

By Promotion:-

- i) M.A. Sanskrit with atleast 50% marks and B.Ed. from recognized university; AND
- ii) 2 years teaching experience as TGT Sanskrit /Sanskrit Teacher; AND
- iii) Certificate of having qualified Haryana Teacher Eligibility Test (HTET)/School Teachers.

The Government made amendment in the 'Haryana State Education School Cadre (Group-B) Service Rules, 2012', vide notification dated 23rd June, 2017 and the education qualification/experience required for promotion to the post of PGT Sanskrit from the post of TGT Sanskrit or Sanskrit Teachers has been amended as under:-

- (i) M.A. Sanskrit/Acharya with at least 50% marks and B.Ed./Shiksha Shastri/Language Teachers Course (LTC)/Oriental Training (O.T.) in Sanskrit from a recognized university or conducted by the Haryana Education Department or an equivalent qualification recognized by Haryana Education Department; AND
- (ii) 2 years teaching experience as TGT Sanskrit/ Sanskrit teacher;

The petitioners have passed the Shiksha Shastri and were not in the possession of B.Ed. degree required for promotion from the recognized University at the time when promotions were made in 2016. The petitioners were found not eligible for promotion according to the rules prevalent at that time and therefore were not promoted. Those who were found eligible were promoted although they were junior to the petitioners.

These promotion orders No.15/18-2016 PGT-II (3) dated 06.05.2016

The amendment dated 23.06.2017 was also challenged in CWP No. 31702 of 2018 titled as Rakesh Kumar & others Vs. State of Haryana & others and the same was disposed of on 06.11.2019, wherein the Hon'ble High Court ordered that the benefit of amendment carried out in 2017 has to be applied retrospectively as the amendment is explanatory and declaratory in nature against which LPA No. 1928 of 2019 was filed before the Hon'ble Division Bench and it was decided on 12.01.2023 wherein amendment was held not retrospective and only prospective. Aggrieved by this order SLP No. 3263 of 2023 was filed in the Hon'ble Apex Court which is still pending and is fixed for 23.09.2024.

The promotion to the post of PGT Sanskrit vide order dated 06.05.2016 as well as the letter inviting preference of posting from the said 138 teachers was again challenged by some of the Sanskrit teachers in CWP No. 11260 of 2020 titled as Balbir Singh and Ors. Vs. State of Haryana & Ors. and this Hon'ble Court was pleased to stay the operation of promotion order dated 06.05.2016 vide order dated 05.08.2020. Lateron, vide order dated 08.08.2023, the Hon'ble Court was pleased to vacate the stay and allowed the respondent department to promote the eligible candidates to the post of PGT Sanskrit.

After vacation of stay by the Hon'ble High Court, the cases of the petitioners for promotion were considered in the year-2023 and petitioners at Sr. No. 2, 3, 4, 5 and 17 have been promoted vide order No. 15/37-2021 PGT 1(1) dated 20.11.2023. Petitioners at Sr. No. 1, 6, 7, 10 and 16 retired before the promotions were made. Petitioners at Sr. No. 8, 9, 11, 12, 13, 14, 15, 18, 19, 20, 21, 22 and 23 were not promoted as their seniority were beyond the seniority number upto which the promotions were made. The case for promotion of these petitioners at Sr. No. 8, 9, 11, 12, 13, 14, 15, 18, 19, 20, 21, 22 and 23 will be considered as per their seniority at the time of making promotions in future.

In view of this, claim of the petitioners is not tenable & hereby rejected being devoid of merits.

I, order accordingly.






