Whereas, Smt. Sudesh Kumari and another had filed CWP No. 10129 of 2024 titled as Sudesh Kumari and another vs. State of Haryana & others praying therein to direct the respondents to promote the petitioners as PGT Sanskrit as the junior to the petitioners have been promoted, but the name of the petitioners were not shown in the promotion list.

The Hon'ble High Court was pleased to dispose of said writ petition vide order dated 03.05.2024 with following orders/direction:-

".....appropriate action will be taken by the second respondent on the pending representations, dated 15.03.2024 and 20.02.2024, within a period of three months.

In view of the statement made by learned State counsel, learned counsel for the petitioners has no objection to the petition being disposed of in terms thereof.

Ordered accordingly".

In compliance of above said order, the representation dated 20.02.2024 and 15.03.2024 of Smt. Sudesh Kumari and another, C&V Sanskrit was perused and examined. After examination, it has been found that Smt. Sudesh Kumari and Smt. Geeta Devi were appointed as C&V Sanskrit on 17.10.2000 and 31.10.2000 respectively.

Whereas, the rules for the promotion prevalent at the time of promotions were Haryana State Education School Cadre (Group-B) Rules, 2012. As per these rules, qualifications for promotion to the post of PGT Sanskrit were as given below:

By Promotion:-

- i) M.A. Sanskrit with atleast 50% marks and B.Ed. from recognized university; AND
- ii) 2 years teaching experience as TGT Sanskrit /Sanskrit Teacher; AND

It is pertinent to mention here that the Government made amendment in the 'Haryana State Education School Cadre (Group-B) Service Rules, 2012', vide notification dated 23rd June, 2017 and the education qualification/experience required for promotion to the post of PGT Sanskrit from the post of TGT Sanskrit or Sanskrit Teachers has been amended as under:-

- (i) M.A. Sanskrit/Acharya with at least 50% marks and B.Ed./ShikshaShastri/Language Teachers Course (LTC)/Oriental Training (O.T.) in Sanskrit from a recognized

university or conducted by the Haryana Education Department or an equivalent qualification recognized by Haryana Education Department; AND

- (ii) 2 years teaching experience as TGT Sanskrit/ Sanskrit teacher;

Whereas, in the year 2015, the department sought promotion cases from the field offices to make promotions to the post of Post Graduate Teachers in various subjects including PGT Sanskrit from the post of Trained Graduate Teachers/C&V Teachers who fulfills the eligibility for promotion on 01.01.2014 as per Haryana State Education School Cadre (Group-B) Service Rules, 2012.

Whereas, the petitioners acquired the qualification of B.Ed in 2015 after the cut off date i.e. 01.01.2014. The cut off date for applying for the promotion by sending the cases through proper channel was 01.01.2014 and hence, the petitioners were found not eligible for promotion to the post of PGT (Sanskrit) and juniors of the petitioners were promoted to the post of PGTs reason being that juniors of the petitioners possess the requisite qualification for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012.

These promotion orders No.15/18-2016 PGT-II (3) dated 06.05.2016 were challenged by some of the Sanskrit teachers by filing CWP No. 12014 of 2016 titled as Dharampal & Ors. Vs. State of Haryana & Ors. and the same was finally disposed of on 06.02.2019.

The amendment dated 23.06.2017 was also challenged in CWP No. 31702 of 2018 titled as Rakesh Kumar & others Vs. State of Haryana & others and the same was disposed of on 06.11.2019, wherein the Hon'ble High Court ordered that the benefit of amendment carried out in 2017 has to be applied retrospectively as the amendment is explanatory and declaratory in nature against which LPA No. 1928 of 2019 was filed before the Hon'ble Division Bench and it was decided on 12.01.2023 wherein amendment was held not to be retrospective and only prospective. Aggrieved by this order, SLP No. 3263 of 2023 was filed in the Hon'ble Apex Court by the aggrieved persons, which is still pending and is fixed for 23.09.2024.

The promotion to the post of PGT Sanskrit vide order dated 06.05.2016 as well as the letter inviting preference of posting from the promoted teachers was again challenged by some of the Sanskrit teachers in CWP No. 11260 of 2020 titled as Balbir Singh and Ors. Vs. State of Haryana & Ors. and this Hon'ble Court was pleased to stay the operation of promotion order dated 06.05.2016 vide order dated 05.08.2020. Lateron, vide order dated 08.08.2023, the Hon'ble Court was pleased to vacate the stay and allowed the respondent department to promote the eligible candidates to the post of PGT Sanskrit.

After vacation of stay by the Hon'ble High Court, the cases of the employees for promotion were considered in the year-2023 and the Departmental Promotion Committee (DPC) has been held on 14.02.2022 regarding the promotion cases of PGT Sanskrit and approved the promotion upto seniority No. 934. Whereas, Smt. Sudesh Kumari is placed at Seniority No. 1625 and Smt. Geeta Devi is placed at 1814. So, the cases for promotion of these candidates will be considered as per law at the time of making promotions in future. Hence, their claim is not tenable and liable to be rejected being devoid of any merits.


