

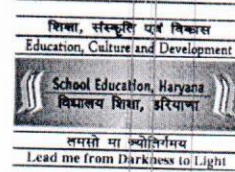



Whereas, Sh. Pawan Kumar [015715], PGT History, Govt. Sr. Sec. School, Alika [952] (Palwal) now Govt. Sr. Sec. School, Udaka (Nuh-Mewat) was chargesheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order No. 16/38-2010 HRL (5) dated 17.05.2010 for carelessness in his duty in violation of rule-3 (iii) of Haryana Civil Services (Govt. Employees Conduct) Rules, 1966 on the basis of the following allegation levelled against him:-

यह कि श्री पवन कुमार, प्रवक्ता इतिहास, रा.व.मा.वि. सोहना (गुडगांव) दिनांक 06.05.2010 नगरपालिका सोहना के क्लेम एवं ओबजैक्शन की सुनवाई के दौरान मौके पर उपस्थित पाया गया लेकिन विद्यालय के निरीक्षण के समय विद्यालय में उपस्थित नहीं था। विद्यालय में देर से आना एवं विद्यालय से अनुपस्थित रहना उसके स्तर पर एक गम्भीर रूप से अनुशासनहीनता को दर्शाता है। ऐसा करके उसने सरकारी कर्मचारी नियमावली-1966 के नियम 3 (iii) की उल्लंघना की है।”

Whereas, Sh. Pawan Kumar, PGT History submitted his reply stating therein that the allegations levelled against him are totally baseless, false and fabricated as he is honest and sincere worker.

Sh. R.P. Bhasin, District & Session Judge (Retired) was appointed as Inquiry Officer in the matter who submitted his enquiry report. He was of the opinion that the charges against the charged officer are proved.

Sh. Pawan Kumar, PGT History was further granted personal hearing on 09.10.2024. During the personal hearing he could not explain his habitual late coming to the school. He also could not explain that he was found absent from the school on 06.05.2010 whereas his presence was marked. The report

from D.C. Gurugram shows that after marking his presence in the school he was participating in claims & objections proceedings in M.C. Sohna.

Therefore, keeping in view the totality of facts & circumstances of the case, I, being competent authority, am of the opinion that punishment of withholding two increments without cumulative effect will be commensurate with his acts of omission & commission. Therefore, punishment of withholding of two increments without cumulative effect is imposed on the charged officer.

I order accordingly.
