Whereas, Smt. Komal made a complaint through C.M Window Portal vide complaint No. CMOFF/N/2020/078063 dated 22.10.2020 alleging that school namely St. Joseph School, Ambala City have not obtained change of land use certificate, building plan approval, building safety certificate, etc.

After receiving the complaint, the District Education Officer, Ambala was directed by the department to enquire the matter and inquiry was conducted under the Chairmanship of Deputy District Education Officer, Ambala.

On the basis of inquiry report dated 18.01.2022, a Show Cause Notice was issued to the appellant school vide memo No. 38/22-2022 PS (4) dated 18.01.2023/03.03.2023. The Director/Principal, St. Joseph School, Ambala City, District Ambala submitted its reply dated 26.04.2023 and after considering the reply, the Director Secondary Education Haryana withdrew the NOC vide order no. 38/22-2022 PS (4) dated 03.07.2024/04.07.2024 which was issued to St. Joseph School, 129, Shazadpur House, Civil Lines, Ambala City, District Ambala vide order no. 23/600-2001 S-I (3) dated 06.12.2001.

The Management of school filed, an appeal dated 15.07.2024 before the Additional Chief Secretary, School Education Department challenging the orders dated 03.07.2024/04.07.2024.

An opportunity of personal hearing was given to both the parties i.e. complainant namely Smt. Komal & appellant i.e. management of school on 05.08.2024. In the course of hearing, the principal, St. Joseph School, Ambala City submitted fire safety certificate/building safety certificate and other documents. In view of the documents submitted by the school management, the order dated 03.07.2024/04.07.2024 was stayed vide order no. 38/22.2022 PS(4) dated 05.08.2024 and O/o District Education Officer Ambala was directed to verify the Building Safety Certificate and Fire Safety Certificate No. FS/2024/26 dated 05.08.2024 submitted by the school management. Thereafter personal hearing was adjourned for 12.09.2024, 14.10.2024 & 04.11.2024.

Whereas, In the course of personal hearing on 04.11.2024, both the parties i.e. complainant namely Smt. Komal & appellant school were present and the report of District Education Officer, Ambala as to the genuinity of the documents was also placed on the record. As per the report, documents submitted by the school were found to be genuine.

Rule 44 of the Haryana School Education Rules, 2003 provides for restoration of NOC/Recognition if the appellant authority is satisfied that the reason



which led to the withdrawal of NOC/Recognition have been removed and the school complies with the provisions of the rules.

Whereas, the No Objection Certificate (NOC) to take affiliation from CBSE which was granted to St. Joseph School, Ambala City, District Ambala vide order no. 23/600-2001 S-1(3) dated 06.12.2001, with the condition that the school concerned to follow all the terms & conditions mentioned in the Haryana School Education Act, 1995, However, the school concerned didn't follow the same and was running without Building Safety Certificate as well as without the fire safety certificate. Giving these reasons, the NOC of the said school was withdrawn by the Director, Secondary Education Haryana, Panchkula vide order no. 38/22-2022 PS(4) dated 03.07.2024/04.07.2024.

In view of the facts mentioned above, the record submitted by the branch & the complainant, the reply of the school management to the show cause notice and the statement made in the personal hearing, the school has obtained required documents i.e. Building Safety & Fire Safety Certificate for current academic session, which are also found to be genuine and the lapses which led to the withdrawal of NOC of the St. Joseph School, Ambala City, District Ambala have been rectified. Furthermore, Rule 31 of the Haryana School Education Rules, 2003 provides that the schools established prior to 31.03.2007 are not required to submit CLU as these school are covered under existing school category and qualify for the relaxed land norms. So exercising my powers under Rule 44 of the Haryana School Education Rules, 2003, the NOC of the St. Joseph School, Ambala City, District Ambala is hereby restored and the school management is directed to strictly follow the Haryana School Education Act, 1995 & as well as Haryana School Education Rules, 2003 in future. However, the fresh grievances raised in the course of appeal by the complainant against the school may be placed by the complainant before the Director, Secondary Education Haryana, who will thereafter look into these grievances & take necessary action.

I order accordingly.

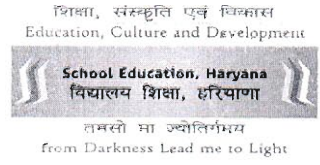

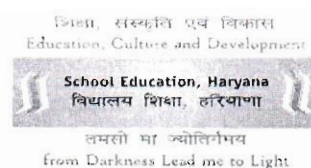
