Whereas, DAV Centenary Public School, Pehowa, Kurukshetra was granted permission for 1st to 12th level vide memo no. 24/118-2003 PS(3) dated 08.10.2003 by the Director Secondary Education Haryana, Panchkula under the provisions of Haryana School Education Rule, 2003.


Sh. Rupesh Kumar filed a complaint dated 11.03.2020 against this school before the Fee & Fund Regulatory Committee, Ambala stating that school has been charging fee in excess of fee submitted in FORM-VI for the academic session 2020-21.

The Fee & Fund Regulatory Committee, Ambala was pleased to pass the following order dated 22.01.2021: -

***"The FFRC concluded that as per Haryana Government notification dated 28.01.2014 and Under Rule 158-A of Haryana School Education Rule, 2003 the mandate of Fee and Fund Regulatory Committee is to see whether a private school has charged any capitation fee or fee in excess of the fee as notified by the school..***

***The allegations of the complainant in Para No. 4 of his complaint in which it is mentioned that "the school has also produced false data in para 7 of the FORM-VI regarding previous session proposed fee charged during the academic session 2018-19 and 2019-20." Besides, he has also stated during the hearing that the school is not conducting online classes. These issues are required to be dealt by the District Education Officer, Kurukshetra by taking up with the Education department. If necessary, in accordance with rules /govt. instructions.***

Whereas, the complainant filed an appeal against the order dated 22.01.2021 of the Fee & Fund Regulatory Committee, Ambala before the Additional Chief Secretary to Government of Haryana. However the first appellate authority under Rule 158-B of Haryana School Education Rules, 2003 is Director Secondary Education Haryana, so the appeal was transferred to Director Secondary Education for adjudication. In pursuance of that appeal, both the parties were heard on 30.09.2022



by the Director Secondary Education, Haryana, Panchkula. The Director Secondary Education, Haryana, Panchkula was pleased to pass the following orders:-

*"There has been a proportional increase in fee charged by the school over the years and there has been no hike. The appellant also had due notice of the fee being charged by the school. Taking into consideration all the above-mentioned facts, I am of the considered opinion that there was indeed a technical glitch in the earlier FORM-VI (which has been corrected vide notification no. 7/24-2020 PS (4) dated 08.12.2021).*

*Also, it is established beyond doubt that the DAV Centenary Public School, Pehowa, Kurukshetra had no mala fide intention in not disclosing the fee in the earlier FORM-VI. Also, the appellant, Sh. Rupesh Kumar cannot take advantage of not paying fee on time in shadow of the complaints & appeal against the respondent school. The order dated 22.01.2021 passed by Fee & Fund Regulatory Committee, Ambala are hereby upheld. Also, appellant parent is directed to pay the pending fee as notified by the respondent school".*

Whereas, present second appeal dated 30.12.2022 has been filed by Rupesh Kumar for setting aside the above mentioned order dated 12.12.2022 passed by Director Secondary Education, Haryana Panchkula.

Whereas vide memo no. 8/29-2021 PS (2) dated 05.09.2024, an opportunity of personal hearing was granted to the appellant and the management of concerned school for 23.10.2024. On fixed date, Sh. Vivek Aggarwal appeared on behalf of School Management and Sh. Rupesh Kumar, appellant, represented himself. I have heard the complainant & the school. The order passed by Director is quite detailed & logical. Further, the complainant has not been able to show that he has been charged in excess of fees notified for academic year 2020-21. The order no. 8/76-2022 PS (1) dated 12.12.2022 passed by the Director Secondary Education, Haryana, Panchkula, requires no interference and is hereby upheld. Therefore present appeal is dismissed.

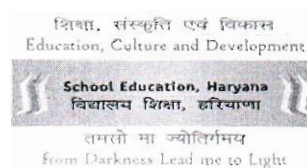

On the recommendation of Haryana Public Service Commission, Panchkula conveyed vide their Memo No. RG-34/2022/8026 dated 30.10.2024, the Governor of Haryana is pleased to appoint the following candidate as Post Graduate Teacher **Physical Education** (HES-II) (Rest of Haryana cadre) against Advt. No. 31/2023 in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600 – 1,51,100/- plus usual allowances as admissible from time to time. He is directed to join at the place of posting as mentioned against his name as under:-

**Terms and conditions:-**

1. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. The candidate shall have to take an oath of allegiance to the Constitution of India.
3. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
4. The candidate shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
5. The candidate shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.



6. In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
7. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. The candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned along with Photostat self attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
9. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining
10. The candidate shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
11. If at any time during the course of temporary appointment, the candidate desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
12. No TA/DA will be admissible to the candidate for joining as PGT.
13. If the candidate gets an appointment as PGT on the basis of furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, the candidate would be liable for termination of service without any notice.
14. This appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
15. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in the self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provisions of Indian Penal Code (IPC) etc as deemed fit.
16. The said appointment are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within stipulated period. This relaxation does not

confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in CS Haryana instruction No. 52/06/2018-2HR-III dated 05.02.2024.

17. The concerned candidate is directed to join duties at place of posting within 15 days and send the joining report (duly signed by DDO) at [dsepgt1@gmail.com](mailto:dsepgt1@gmail.com), failing which this offer of appointment letter will be deemed to have been withdrawn.







Whereas, the petitioner, Saraswati Educational and Charitable Society, Kalawar, Yamuna Nagar through its authorized Representative President Leela Ram filed a CWP No. 9878 of 2024 titled as Saraswati Educational and Charitable Society, Kalawar, Yamuna Nagar V/s. State of Haryana & Others praying for the issuance of a writ in the nature of mandamus directing the respondent to decide the application for grant of interim relief filed along with the appeal on 23.03.2024/27.03.2024 (Annexures P-2 to P-4).

Whereas, the Civil Writ Petition was disposed of by the Hon'ble High Court on dated 01.05.2024. The operative part of the order dated 01.05.2024 is as under:-

*".....Keeping in view the above said facts and circumstances, the present Civil Writ Petition is disposed of with directions to the office of Appellate Authority before whom the appeal (Annexure P-4) is pending to list the appeal before the Appellate Authority within a period of one week from today in case the same is complete in all aspects and the Appellate Authority is further directed to take up the matter for preliminary hearing and consider the prayer of the petitioner for interim directions as prayed in the application dated 23.03.2024 (Annexure P-2) and pass appropriate orders on the same within a period of 10 days from the date of listing of the said appeal."*

Whereas, the Saraswati Public School, Village Kalawar, Yamuna Nagar was granted permission from Classes 1st to 12th vide order No. PSE052023595 dated 07.08.2023 by the Director Secondary Education Haryana, Panchkula under the provisions of Haryana School Education Rules, 2003 on the basis of ownership of land bearing Khasra No. 29//26, 27//3 (16 Kanal 1 Marla or 8025 sq. mtrs.).




However, a complaint was received from Sh. Gina Chand Jain, Vice President, Society for Education and Research, Yamuna Nagar against the Saraswati Public School, Village Kalawar, Yamuna Nagar alleging that the said school has taken permission by submitting false land related documents and the school building is actually situated on the piece of land belonging to the Institute of Science & Technology since year 2007-2008.

After due enquiry from District Education Officer, Yamuna Nagar, the permission granted to the Saraswati Public School, Yamuna Nagar was cancelled by Director Secondary Education, Haryana, Panchkula vide order dated 12.03.2024. The school management has filed this appeal for setting aside the order of Director Secondary Education, Haryana, Panchkula for cancelling its permission to run the school.

Whereas, in compliance of the above said order of the Hon'ble High Court, the appeal dated 23.03.2024/27.03.2024 of the petitioner has been examined in detail. An opportunity of personal hearing was granted to the School Management on 05.11.2024 vide letter no. 6/139-2023 PS (1) dated 28.10.2024. On 05.11.2024 Sh. Rajiv Kumar Saini, Advocate appeared on behalf of the school management. However, he failed to produce document showing ownership of the requisite land in favour of school and prayed for permission to withdraw the appeal. In view, of this the appeal is dismissed as withdrawn.

On the basis of recommendations made by the Haryana Staff Selection Commission, Panchkula, appointment order was issued to you vide this office memo No. 6/2-2024 PGT-I (2)/ Sanskrit dated 23.01.2024 subject to the terms and conditions mentioned in the appointment orders. As per condition No. 19 of the appointment order/letter, you were directed to join at the allotted station within 15 days from the date of issuance of appointment letter. Thereafter, you were granted three months extension for joining vide letter dated 21.02.2024. But you have not joined at the allotted school so far and you have never requested for any further extension in time period for joining.

However, before initiating any action, the department issued a show cause notice on 16.09.2024 to you, as to why your candidature for the post of Post Graduate Teacher in Sanskrit may not be cancelled. Reply, if any, in response to that notice was to be filed in the office of Director Secondary Education, Haryana, Panchkula within 15 days from the date of the receipt of that notice. But, you neither gave any response to that notice nor requested for extension of service nor joined to the allotted station/school.
