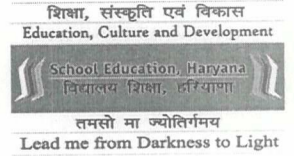



Smt Parveen Kumari [040259], Principal, Government Girls Senior Secondary School Bahadurgarh, Jhajjar was charge-sheeted under rule -8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order dated 11.09.2024/16.09.2024 and the following allegation was levelled against him:-

"While posted as Principal, Government Girls Senior Secondary School, Jasaur Kheri Barota [3088], Jhajjar from 03.09.2022 to 10.07.2024, Smt Parveen Kumari has committed the following acts of omission and commission for which following allegations are leveled against her: -

That Smt Parveen Kumari, Principal, GGSSS Jasur Kheri [3088], Jhajjar was found absent from duty on 19.03.2024 at the time of surprise inspection of Gram Panchayat although the attendance was marked in the attendance register. Further, Committee of Vigilance Wing Chaired by Shri Dalbir Singh, Deputy Director, Office of Director Secondary Education, Haryana, Panchkula inspected the Government Senior Secondary School, Jasaur Kheri [3088], Jhajjar on 25.04.2024 and found that dance coaching was given to the girl student by a choreographer named Mr. Javed, but in this regard neither the school Principal took permission from any competent authority nor any resolution was passed by the SMC committee. Cash amount was paid to Javed Choreographer along with this she i.e Smt Parveen Kumari has sent the girls on tours with Shri Javed without any permission. During the investigation, it was found that there is a lot of anger against the Principal and there is a tense situation in the school and the following irregularities have been found to be committed: -

That you, Smt Parveen Kumari being Principal appointed choreographer named Mr. Javed, for the dance coaching of girl student without permission of competent authority and resolution SMC Committee.


That you, Smt Parveen Kumari being Principal created/made the environment of the school stressful for the students to study of students and your behavior towards the villagers is also arrogant."

Smt Praveen Kumari [040259], Government Senior Secondary School Bahadurgarh, Jhajjar submitted the reply on 19.09.2024 to the said charge-sheet and denied the allegation leveled against her. The delinquent replied for alleged absence on 19.03.2024 that she was accompanying students to the Brigadier Hoshiyar Singh Metro Station for their tour to Panchmadi. The delinquent appointed a Musician-cum-Choreographer to guide students in their cultural performance during a district level competition under his guidance the students secured first position in the completion. With regard to unauthorized tours she replied that no school funds were utilized for this trip.
