On the recommendation of the Haryana Staff Selection Commission, Sector-2, Panchkula, vide their letter No. HSSC/Confid./CA-14/CET- Group-C/2024/665 dated 19.10.2024 against Advt. No. 04/2024, Category 380 **Sh. Rahul Moga S/o Sh. Sube Singh, (Merit No. 8, Roll No. 4245727822, EWS)** is hereby appointed as Clerk on provisional basis in the Directorate of School Education, Haryana, Panchkula in the pay band FPL-3 (21700-69100) of Schedule-I pay matrix of Haryana Civil Services (Revised pay) Rules, 2016 plus usual allowances as sanctioned by the Haryana Government from time to time, with effect from the date he resume their duties in this office on the terms and conditions mentioned herein after:-

TERMS & CONDITIONS:-

1. His appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. His services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
2. This offer of appointment is PROVISIONAL in terms of instructions No. 52/06/2018-2HR-III dated 11/10/2024 issued by the Chief Secretary to Government, Haryana, Human Resources Department and subject to the following conditions: -
 - i. This provisional appointment letter is subject to the condition that candidate will submit the self declaration certifying that all facts and details given in the form are correct before submitting his/her joining letter.
 - ii. This provisional appointment is without verification of your character and antecedents at this stage and hence in case character and antecedents of candidate is found not verified or false information is given by the candidate in his/her self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/civil/legal action will also be taken,



as a consequence. The candidate shall be rendered unfit for any Government employment.

- iii. You shall have to submit your medical fitness certificate duly signed by the concerned District Chief Medical Officer as required under Rule 9 of the Haryana CSR (General), 2016 within a period of two months from the date of joining.
 - iv. This provisional appointment is subject to matching of Biometric/Facial Verification Attendance within two weeks from the date of joining as per instructions dated 11.10.2024 of Chief Secretary.
 - v. In case of unfitness in any of above conditions the services of newly appointed employee will be terminated immediately without any notice.
3. If at any stage you desire to resign his post he will be required to give one month's notice or forfeit in lieu thereof, his salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate his service for the reason other than that mentioned in clause (I) above.
 4. He will be required to take the prescribed oath of allegiance to the Constitution of India.
 5. In case you are married, he will produce the following certificate to his/her Head of office:- "That he/she is not having more than one living spouse." In case they are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.
 6. In case you are married, you will have to furnish a declaration to the Head of the Department that he has not taken any dowry at the time of marriage. The declaration should be signed by his wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
 7. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
 8. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
 9. He will be required to produce the original Educational documents and date of birth certificate before joining their duties of the said post.
 10. He shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining their duties.



11. He shall get themselves vaccinated and re-vaccinated at any time when so directed by the Government by general or special order.
12. No TA/DA and joining time will be paid to him for joining this post.
13. He will remain on probation for a period of two years, from the date of his joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing their performance during the period of probation, their work and conduct will be taken into consideration. If their work and conduct during this period is not found satisfactory their services will be terminated without any notice.
14. His appointment is subject to have passed 10+2 or its equivalent examination with Hindi/Sanskrit.
15. That in the matters, not specifically mentioned in this communication, they shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. They shall further be governed by the "Haryana Education Directorate (State Service Class-III) Rules, 1974" as amended from time to time.
16. His services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
17. The DESM/ESM category candidates will have to furnish a fresh eligibility certificate duly issued by Zila Sainik Board to the effect that he/she has not availed of the benefit of dependent of Ex-serviceman and has not availed any other benefit in any manner.
18. That if you got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be false or forged or fraudulent, you would be liable for termination of your services without any notice. Besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other law in force.
19. That in case of reserved Category candidates, your appointment is subject to the verification of your domicile, Castes, Socio-Economic criteria and other certificates.
20. At this stage, all relevant documents are not being checked and verified, therefore, any discrepancy found in your documents at any stage will liable you to be terminated without any notice.
