



Ram Khiladi, Clerk, O/o District Elementary Education Officer, Nuh/Mewat is hereby informed that it is proposed by the Governor of Haryana to take action against him under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016, on the grounds set out in the enclosed statement of charges. The charges are based on the statement of allegations appended thereto.

1. **Sh. Ram Khiladi, Clerk** is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by him whether he admits the truth of all, or any, of the charges, what explanation or defence, if any, he has to offer and whether he desires to be heard in person.
2. **Sh. Ram Khiladi, Clerk** is hereby further informed that if for the purpose of preparing the written statement, he wishes to have access to the relevant official records, he should inspect the same in the office of the Director, Secondary Education, Haryana, Panchkula on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director, Secondary Education, Haryana, Panchkula and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If **Sh. Ram Khiladi, Clerk** wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to **Sh. Ram Khiladi, Clerk** that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.


Statement of allegations against Sh. Ram Khiladi, Clerk O/o District Elementary Education Officer, Nuh/Mewat

While being posted as Clerk in O/o District Elementary Education Officer Nuh/Mewat from 10.11.2023 to 15.01.2024. Sh. Ram Khiladi, Clerk has committed following acts of omissions and commissions for which he is alleged as under:

“The Hon’ble Punjab and Haryana High Court disposed of the CWP No. 20349 of 2024 titled as Mohd. Afsar & Others Vs. State of Haryana and others on 14.09.2023 with the direction to respondent No. 2 i.e. the Director General School Education, to consider and decide the pending legal notice dated 25.05.2023 by passing a speaking order in accordance with law within a period of eight weeks. As per letter No. 12/29-2023 PRT/Guest (1) dated 10.11.2023 of the Directorate of Elementary Education, Haryana. The direction was given to DEEO Mewat to comply with the orders of the Hon’ble High Court but Sh. Ram Khiladi, Clerk did not give any attention to this aforesaid letter till 04.09.2024. Thereafter, repeated telephonically calls were made for seeking information accordingly, failed to provide information, after that the speaking order was issued on 05.09.2024. In this way, Sh. Ram Khiladi, Clerk caused the delay to provide the information and compliance could not be made in time. Resultantly, COCP No. 2700 of 2024 arose in CWP No. 20349 of 2023 & the department had to face the hardships before the Hon’ble High Court.

In this way, Sh. Ram Khiladi, Clerk had shown lack of responsibility & devotion to duty and acted in a manner which is unbecoming to a Government Official of his status, thereby violated the provisions of rule 4(1) and 4(2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Sh. Ram Khiladi, Clerk rendering himself liable for strict disciplinary action under Rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.






