I am directed to refer to the subject noted above and to enclose herewith a copy of letter No. SEC/2ME/2024/1839, dated 11.12.2024 issued by State Election Commission, Haryana alongwith Notification No SEC/2ME/2024/1805, 1807 and 1818 & 1820, dated 07.12.2024 and 09.12.2024 for the preparation of photo based wardwise electoral rolls of the Municipal Corporation, Ambala, Faridabad, Manesar, Gurugram, Sonapat and Municipal Councils/ Committees Ambala Sadar, Barara (Ambala), Bawani Khera, Loharu, Siwani (Bhiwani), Jakhhal Mandi (Fatehabad), Pataudi Jatauli Mandi, Farukh Nagar (Gurugram), Narnaund (Hisar), Beri (Jhajjar), Julana, Safidon (Jind), Kalayat, Siwan, Pundri (Kaithal), Indri, Nilokheri, Assandh, Taraori (Karnal), Ismailabad, Ladwa (Kurukshetra), Ateli Mandi, Kanina (Mahendergarh), Taoru (Nuh), Hathin (Palwal), Kalanaur (Rohtak), Sirsa (Sirsa), Kharkhoda (Sonapat) and Radaur (Yamuna Nagar) As per programme, the draft electoral rolls shall be published on 17.12.2024 and the claims and objections shall be received by the revising authority concerned by 23.12.2024. The final publication of electoral rolls shall be done on 06.01.2025.

2 It is, therefore, requested that the officers/officials involved in the preparation of electoral rolls of these Municipal Corporations/ Councils/ Committees may not be transferred till the final publication of electoral rolls. However, in case, where it is considered absolutely necessary to transfer any officers/officials connected with the above said duties, prior written approval of the State Election Commission must be obtained.
