In continuation of this office letter no. kw 8/34-2019 PS (2) dated 06.12.2024 and in reference to your letter no. 6347/affiliation dated 20.12.2024 on the subject cited above.

Please find enclosed herewith the list of existing schools received from the District Education Officers Concerned to whom the Government decided to grant provisional affiliation for the current academic session 2024-25. The categories of the school are as under: -

Sr. No.	Category of School	Class for which provisional affiliation is extended
1	Schools in existence before the commencement of the Haryana School Education Rules, 2003 (i.e., 30th April 2003) and running classes beyond their permanent recognition. For example, schools with permanent recognition up to 8th class but running classes up to 10th or 12th.	Provisional affiliation is extended for classes beyond permanent recognition, valid for schools granted affiliation in 2023-24. No fresh bond is required as the previous bond will be treated as valid.
2	Schools granted temporary recognition from the Department before 30th April 2003.	Provisional affiliation is extended up to the temporarily recognized classes, valid for schools granted affiliation in 2023-24.
3	Schools with permission to establish between 30th April 2003 to 31st March 2007 and granted provisional affiliation by the Board of School Education Haryana (Bhiwani).	Provisional affiliation is extended up to the classes for which the Board has been granting provisional affiliation annually, valid for schools granted affiliation in 2023-24.





You are requested to:

- Open the portal and allow all private schools mentioned in enclosed list to deposit the affiliation fee (as per the Board norms) for the academic session 2024-25 if affiliated by the board for previous academic session 2023-24.
- 2. Also entertain applications from the schools not listed in the enclosd list, provided they submit valid proof such as:
  - Copy of Affiliation granted by the Board for the previous academic session (2023-24).
  - Copy of temporary recognition/permission certificate/affiliation letter of Board issued before 31st March 2007.
- 3. After doing the needful, please provide the final list of all the schools verified and granted affiliation for the academic session 2024-25 to this department for records and compliance.
- 4. Other Terms & Conditions mentioned in letter no. kw 8/34-2019 PS (2) dated 06.12.2024 will also be applicable and will remain same in this matter.
