**ORDER**

On the recommendation of Haryana Staff Selection Commission, Panchkula conveyed vide their Memo No. HSSC/Conf./Recomm/01/126/2024/CA-11/971 dated 20.12.2024, the Governor of Haryana is pleased to appoint the following candidate as Post Graduate Teacher **Biology** (HES-II) (Rest of Haryana cadre) against Advt. **Terms and conditions:-**

1. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. The candidate shall have to take an oath of allegiance to the Constitution of India.
3. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
4. The candidate shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
5. The candidate shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.

7. 8. 15.
