The posting of officers are subject to the following terms and conditions:-

3. That these promotion/posting orders are without prejudice to the right of the seniors, if any, whose promotion cases may be decided at a later stage/ and court case pending/ directions etc.
4. That these officers should fulfill the conditions as prescribed in the Service Rules / approved terms and conditions. In case it transpires at a later stage that any employee does not fulfill the conditions as

- prescribed" in the service rules, he/she shall be reverted / relieved to his original post immediately. After their posting all DDO's are again directed to check the record that they fulfil the conditions/parameters.
5. They will have to join their duties at the place of new assignment within 7 days from the date of issue of promotion/posting orders failing which these orders shall stand automatically cancelled.
 6. No TA/DA will be admissible to the officers.
 7. The officers will update their profile in MIS Portal when he/she join/relieve from his/her present working station and also supply the information to the Directorate within 3 days positively.
 8. Concerned DDO's are also directed to update and approve MIS data of the officers at their own level within 3 days positively.

Note: The terms and conditions in promotions orders of the officer issued on dated 31.12.2024 will remain same.
