I am directed to invite your kind attention to the Government instruction issued vide circular No. 9/4/88-2PS, dated 10.08.2018 on the subject noted above and to say that the State Government has decided to amend the said instruction to the extent that the cost of uniform upto INR 5,280/- (inclusive of GST) shall be reimbursed to all Group 'D' employees (eligible as per Rule 19 of HCS (allowance to Government employees) Rules, 2016) on yearly basis on production of valid bill thereof, instead of paying INR 440/- per month with salary. This will take effect from the financial year 2025-26 onwards.

2. This issues with respect to the advice tendered by the Finance Department vide their U.O.No. 04/02/2017-5FR/11883 dated 24.07.2021.
