**ORDER**

**Order No. 23/99-2024 Pen-1(3)**

**Dated, Panchkula**

Whereas, the petitioner namely Brij Mohan has been filed CWP 19688 of 2024 titled as Brij Mohan Vs State of Haryana & ors, inter alia, seeking a writ of mandamus directing the respondents to consider the representations dated 09.08.2024 and 12.06.2024, Annexures P-20 & P-21 respectively, and release withheld benefits of service gratuity and commuted pension as per the statutory provisions of Haryana Civil Services (Pension) Rules, 2016.

Whereas, the Civil Writ Petition was disposed of by the Hon'ble High Court on dated 13.08.2024. The operative part of the order dated 13.08.2024 is as under: -

*“.....In view thereof, without going into merits of the case, the petition is disposed of with a direction to respondent No.2/Director Secondary Education, to consider and decide the pending representation, dated 09.05.2024, Annexure P-20, by passing a speaking order in accordance with law, within a period of three months from the date of receiving a certified copy of this order.”*

Whereas, in compliance of the above said order of the Hon'ble High Court, the representation dated 09.05.2024 of the petitioner has been examined in detail in light of the statutory provisions, services rules, and the available records. Shri Brij Mohan, retired District Elementary Education Officer (DEEO), Panipat, superannuated on 31.05.2023. At the time of his retirement, his provisional pension was sanctioned vide PPO Number 11234296944296944, but DCRG and commutation benefits were withheld due to the pendency of Complaint Nos. 248/2022 and 57/2023 filed by Shri Subhash, before the Lokayukta. Shri Brij Mohan in his representation dated 09.05.2024, stated that in Complaint No. 248/2022, filed by Shri Subhash, he was found innocent. He further submitted that Complaint No. 57/2023 is also based on a similar subject matter and is still



pending before the Lokayukta. As per the Haryana Civil Services (Pension) Rules, 2016, the petitioner, being a retired government employee, is entitled to service gratuity (DCRG), leave encashment and commutation of pension and it can be released in view of the Rule 81 of the above mentioned Rules. The sanctions of leave encashment vide Order No. 10/11-2023 HRG-1(4) dated 20.09.2023 has been allowed to the petitioner and case of DCRG amounting of Rs. 24,84,207/- and Commutation of Pension amounting of Rs.17,27,461 has been forwarded to the office of the Accountant General (A&E), Haryana, Chandigarh vide Memo No. 11/1-2023 Pension-1(3) dated 24.01.2025, for further processing of the disbursement of benefits. In the circumstances claim of the petitioner is settled.

I order, accordingly.
