SHOW CAUSE NOTICE

Dated, Panchkula:

Whereas B.R.D.M High School Kaithal was granted paramanent recognition upto 10th level vide order no. 23/449-2000 S-1 dated 09.10.2000 by the Joint Director, Secondary Education Haryana, Panchkula

Whereas, the District Education Officer, Kaithal informed vide letter G-1/2024/1317 dated 18.09.2024 that the B.R.D.M High School Kaithal had applied for up-gradation. That the regarding recognition of the above school, inspection was done by the District Level Committee on 08.08.2024. The report consisted of following observations:-

1. *There are 6 single door classrooms in the school and they are not as per departmental norms.*
2. *The staff members of the school do not fulfill the departmental norms and neither the appointment letter nor the agreement under Rule 161 was found to have been obtained.*
3. *At the time of inspection by the school head, the pattanama, sizra and land ownership records related to the land were not presented nor was the map of the building presented.*
4. *Fire certificate, hygienic certificate and Building Safety certificate was not submitted. There was no fire extinguishers in the school.*
5. *There is no Stairs /Ramp in the school building keeping in mind the safety of the children.*
6. *There is no alternative door in the school building keeping in view the safety of the children.*
7. *There is no proper arrangement of any science laboratory in the school building. There is no electricity in the school classroom.*
8. *The school head has not submitted any document related to the Pracharak Samiti.*
9. *There is no playground in the school, nor has the school made any arrangements for any other playground within 1 km as per the rules.*

Whereas Rule 159 of Haryana Education Code 1978 mandate compliance with departmental norms and regulations for recognition and up gradation of schools and Rule 214 provided that the schools has to ensure that all staff members prescribed qualification standards and that their appointments are formalized through valid agreements or appointment letters. Rule 163 the mandate the availability of essential facilities such as laboratories, library services, and playgrounds. Haryana School Education Act, 1995 requires schools to have suitable or adequate accommodation and sanitary facilities and all teachers should meet prescribed qualifications.

It requires schools to provide facilities for physical education, library services, laboratories, and co-curricular activities.

Whereas the school was granted recognition on the condition that it shall abide by the rules, regulations, and instructions of the appropriate authorities issued from time to time. It is apparent from the above stated facts that the school is being run in violation of the departmental norms/regulation.

Whereas Rule 42 of the Haryana School Education Rules, 2003 provides that the appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued there under to the managing committee either directly or through Principal/ Head of the institution.

Therefore, a show cause notice is being issued to the management of the said school as to why the recognition granted to the school be not withdrawn under Rule 42 of the Haryana School Education Rules, 2003.

The Management of the school, if wants to submit any reply should submit to undersigned within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules.



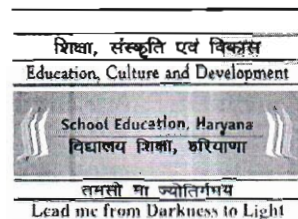

Whereas, Sh. Shiv Kumar and another have filed the present writ petition No. 22560 of 2023 with the prayer for quashing the impugned order dated 12.12.2022 (Annexure P-26) vide which the orders dated 09.11.2022 (Annexure P-13 to Annexure P-24) were withdrawn and for quashing the seniority list as on 27.06.2019 (Annexure P-8) vide which the private respondents have been shown senior to the petitioners in violation of the Haryana State Education (School and Inspection Cadre) (Group-B) Service Rules, 1998 (Annexure P-3). The petitioners further prayed for directing the respondents to restore the order dated 09.11.2022 vide which ante-dated promotion of private respondents were withdrawn and 30.11.2022 (Annexure P-25) vide which the seniority of Principal as on 27.06.2019 was amended and the petitioners were shown senior to the private respondents. The petitioners further prayed for directing the respondents not to promote the private respondents to the post of Block Education Officer/Dy. District Education Officers.

That the present case came up for the hearing before this Hon'ble Court on 05.09.2024 and the same has been adjourned to 04.11.2024. The Advocate General, Haryana, Chandigarh has directed that written statement parawise in this writ petition may be prepared and sent to this office for approval/vetting immediately as no further adjournment will be allowed if the written statement is not filed in time, the Hon'ble Court may pass an order against the interest of state and may also impose costs.

The matter was examined and found that Shri Kundan Kalra [002823] was wrongly placed at seniority no. 1099 of PGTs as stood on 01.04.2005 and promoted as Principal vide order no 4/30-2007 HRG-1(2) dated 20.07.2007. As a result of which, the officers senior to Shri Kundan Kalra [002823] filed various writ petitions for antedated promotion w.e.f. 20.07.2007 at par with Shri Kundan Kalra [002823] and were promoted as principal w.e.f. 20.07.2007.

The Directorate again issued rectified seniority list of PGT's cadre and published provisional seniority list of PGT Cadre on departmental website on 04.09.2024. As per this rectified seniority list of PGT Cadre, the seniority of Shri Kundan Kalra [002383] has now been fixed at 183 and the promotion order of Shri Kundan Kalra is already modified on 21.04.2012 instead of 20.07.2007 and the orders granting antedated promotions w.e.f. 20.07.2007 at par with Shri Kundan Kalra, have to be modified w.e.f. 21.04.2012 instead of 20.07.2007.

Hence, the date of promotions as Principal of Shri Kundan Kalra [002823], Principal (Retd) was modified from 20.07.2007 to 24.04.2012 by passing order dated 08.09.2022/09.09.2022 with the condition that no recovery shall be made from him for the period he actually worked as Principal and pension is to be re-fixed with immediate effect.
