SPEAKING ORDER**

**Order no. 6/187-2024 HRG-I(1)**

**Dated Panchkula, the 03/02/2025**

Whereas, petitioner has filed the CWP no. 25590 of 2024 titled as Vijay Kumar Sachdeva v/s State of Haryana with prayer for quashing the impugned promotion order dated 14.02.2023 (P-6) qua Sr No. 16 i.e. respondent no. 3 vide which junior to the petitioner has been promoted to the post of Block Education Officer (BEO) and to granted antedated promotion to the petitioner to the post of Principal w.e.f. 23.08.2007 i.e. from the date his junior has granted antedated promotion and further grant promotion to the post of Block Education Officer w.e.f. 14.02.2023 i.e. from the date his junior Shri Shyam Sunder Ahuja, respondent no. 3 has been promoted.

That, this case came up for hearing on 03.10.2024 before Hon'ble Punjab & Haryana High Court which was disposed of with direction to the respondent department. Now, the operative part of order dated 03.10.2024 is reproduced as under:-

**2. Notice of motion.**

**3. Ms. Tanushree Gupta, DAG, Haryana, accepts notice and submits that the pending legal notice shall be decided by respondent No.2 expeditiously.**

**4. In view thereof, without going into merits of the case, the petition is disposed of with a direction to respondent No.2/Director General, Secondary Education, to consider and decide the pending legal notice, dated 19.07.2024, by passing a speaking order in accordance with law, within a period of three months from the date of receiving a certified copy of this order. In case the petitioner is found entitled to the benefits claimed, the same shall be released to him within a period of six weeks therefrom.**

**5. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹50,000 to the petitioner.**

In compliance of above orders of the Hon'ble High Court, the legal notice dated 19.07.2024 of the petitioner has been examined and found that the petitioner i.e. Shri Vijay Kumar Sachdeva [038675] was appointed as Lecturer in English on 15.10.1991 and promoted as Principal on 08.01.2009.

Whereas, Shri Shyam Sundar Ahuja [031067] was appointed as Lecturer in Mathematics on 25.10.1991 and promoted to the post of Principal on 24.04.2012. Thereafter, he was granted benefit of antedated promotion as Principal w.e.f. 23.08.2007 vide order no. 6/137-2018 HRG-I(1) dated 15.04.2019 in compliance of order dated 20.08.2018 passed by the Hon'ble High Court in CWP No. 20757 of 2018 titled as Dr. Shyam Sunder Ahuja v/s State of Haryana. Thereafter, he was promoted to the post of Block Education Officer vide order no. 4/15-2022 HRG-I(5) dated 14.02.2023.


That Shri Shyam Sundar Ahuja [031067] was given show-cause notice vide order no. 6/117-2023 HRG-I(3) dated 04.11.2024 to explain his position as to why the antedated promotion granted w.e.f. 20.07.2007 may not be withdrawn and order

*ju*

dated 19.01.2025 was passed vide which the aforesaid show cause notice was confirmed and the benefit of antedated promotion as principal w.e.f. 23.08.2007 has now withdrawn and as such the date of promotion of Shri Shyam Sundar Ahuja [031067] as principal has been modified to 24.04.2012 and his seniority as principal has also re-fixed at 1334 A as stood on 01.02.2023 vide order no. 6/117-2023 HRG-I(3) dated 29.01.2025.

Keeping in view of the above mentioned facts, there is no force in the legal notice dated 19.07.2024 of the petitioner and thus, the claim of petitioner is not maintainable at this stage. Hence, the claim of the petitioner is hereby rejected.

**SPEAKING ORDER**

Order no. 6/205-2024 HRG-I(1)

Dated Panchkula, the 02/01/2025

Whereas, the petitioners have filed the Civil Writ Petition No. 31941 of 2024 titled as Rajpal and another v/s State of Haryana for quashing the action of the respondent whereby they have not offered all the vacant stations to the petitioners and quashing the list/letter dated 19.11.2024 (P-4) to the extent that the respondents have allotted the stations to the petitioner at a very far place.

That this case came up for the hearing before the Hon'ble Punjab & Haryana High Court on 18.12.2024 which was disposed of with direction to the respondents. Now, the aforesaid order is reproduced as under:-

**The petition has been filed against the respondents' decision not to offer all vacant stations to the petitioners for the purpose of filling up of preferences for allotment of stations, and quashing the list/letter dated 19.11.2024, Annexure P-4, to the extent the petitioners have been allotted stations at a far away place.**

**2. Learned counsel for the petitioners submits that at this stage, the petitioners will be satisfied in case they are permitted to make fresh representation(s) before the respondents raising the grievance as has been raised in this petition, and the same may be ordered to be decided within a specified period.**

**3. Learned State counsel, appearing on advance notice, contends that in case any such representation(s) is/are filed by the petitioners within one week from today, the same shall be decided by the second respondent- Director, Secondary Education, by passing a speaking order thereupon, within a period of six weeks of receiving the representation(s).**

**4. In view of the statement made, learned counsel for the petitioners has no objection to the petition being disposed of in terms thereof.**

**5. Ordered accordingly.**

**6. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹50,000 to the petitioners**

In compliance of order dated 18.12.2024, the petitioners have made representation dated 20.12.2024 whereby it has requested that the stations are lying vacant may also be added in the offered list. It has also been mentioned that the stations at GGSSS Kosli [2547], Rewari, GSSS Juddi [2614], Rewari and GSSS Bawwa [2611], Rewari are also vacant.

On examination of the record, it is found that the respondent department made promotion to the post of Principals (Rest of Haryana Cadre) amongst Post Graduate Teachers & Headmasters vide order no. 4/9-2023 HRG-I(1) dated 29.10.2024 and they were allotted temporary stations on 19.11.2024 through online counselling, subject to the condition that they will participate in the next transfer drive, for which the following criteria was adopted:-

That the petitioner no. 1 was posted in district Sirsa at Government Senior Secondary School Keharwala (Sirsa) [2830] under anywhere category though the petitioner no. 2 was given the station of his choice at District Sirsa as per their MIS points as stood on 14.11.2024. Thus, the petitioner no. 2 was posted at the station of his choice through online counselling. As regard, the vacancy position is concern, the position is tabulated as under:-

That the newly promoted principals through online counselling were posted in the school cluster school+ PM Shri + Model Sanskriti School and common

schools having the students strength of 484 or more by the respondent departments the respondent department intended to post the newly promoted Principals in the common schools having higher students strength so that the study of student may not suffer in the absence of an administrator in the school. Further, the stations desired by the petitioners are those whose student's strength are less 484 students which were not offered during counselling. Thus, there is no force in the representation dated 20.12.2024 of the petitioners. Resultantly, the claim of the petitioner is hereby rejected.
