Whereas, Sh. Man Mohan S/o Sh. Dharam Singh [Roll No. 41602689, Category - General] was appointed to the post of PGT Sanskrit under Advt. No. 4/2015, Category No. 16, as per office order No. 6/2-2024 PGT-1 (2) dated 23.01.2024 based on the recommendation received from Haryana Staff Selection Commission (HSSC) through their Memo No. HSSC/Confd/01/05/2024/25 dated 12.01.2024 in compliance of orders passed by the Hon'ble Supreme Court in SLP No. 3263 of 2023 titled as Tarsem Sharma & others V/s State of Haryana & others.

Further, he was posted to the Government Girls Senior Secondary School Palwal City (Palwal) [992] and directed to join his duties within 15 days at the designated station. However, following the issuance of the appointment order, he did not join his duties within the stipulated period.

(i) Since only 7 ex-servicemen candidates were found eligible against 27 posts reserved for them, let the unfilled 20 posts reserved for ex-servicemen be converted into open category and be offered to the next candidates in order of merit.

(ii) 18 posts are admittedly lying vacant. These 18 posts be also filled up amongst the selected candidates in order of merit.

3. It is not in dispute that 22 candidates have not joined so far, though the appointments were offered to them almost one year back. We are informed that their request for an extension of time is still pending. Let all these candidates be asked to join on or before 31.12.2024 and in case they fail to join, such unfilled posts be also offered to the next

candidates in order of merit strictly as per the order dated 12.02.2024 read with order dated 04.11.2024. In this manner, approximately 60 appointments are required to be made.

4. *Let the needful be done on or before 31.01.2025.*


