Sh. Mukesh Kumar and others have filed Civil Writ Petition No. 32740 of 2024 titled as Mukesh Kumar and others vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court with prayer to issue a writ in the nature of mandamus directing the respondents to rectify the seniority list of PGT dated 08.07.2019 & dated 04.09.2024. It has been further prayed for direction to consider name of petitioners for promotion on the post of Principal w.e.f. the date their colleagues/juniors have been promoted i.e. 26.04.2023 with all consequential benefits. And direction may kindly be issued to respondents to consider and decide legal notice dated 07.10.2024 within the prescribed period.

The Hon'ble High Court disposed of the said writ petition vide order dated 04.12.2024 and operative part of this order is reproduced here as under:-

***".....Mr. Ravinder Singh Budhwar, Addl. AG, Haryana, accepts notice on behalf of the respondents/State and submits that the pending legal notice, dated 07.10.2024, will be decided by the second respondent-Director Secondary Education, by passing a speaking/reasoned order in accordance with law within a period of three months.***

***5. In view of the statement made, learned counsel for the petitioners has no objection to the petition being disposed of in terms thereof.***

***6. Ordered accordingly.***

***7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of 50,000 to the petitioners."***

Whereas, in compliance of said order, the legal notice dated 07.10.2024 of petitioners have been examined. The petitioners submitted that they were appointed as Lecturer in Maths, English and Sanskrit in the year-2004 in pursuance of selection made Against Advt. 1/99 dated 14.11.1999. Before the recruitment process completed, the department promoted 1352 teachers as lecturer in various subjects between the years 2000 to 2004 and 556 teachers were also regularized under regularization Policy-2003. These promoted and regularized teachers have been placed above the petitioners in the seniority list. The petitioners have claimed that as they were appointed against the posts advertised in the year-1999 vide advt. no. 1/99, therefore, they must be placed above and over the teachers who were promoted or regularized after the advertisement No. 1/99.

Whereas, seniority of teachers is governed by Rule-11 of Haryana State Service Rules 1998, which is reproduced here as under:-

**Seniority:**

**11. Seniority, inter se of the member of the Service shall be determined by the length of regular continuous Service on any post in the service:**

**Provided that where there are different cadres in the Service, the seniority shall be determined separately for each cadre:**

**Provided further that in the case of a member appointed by direct recruitment, the order of merit determined by the Commission shall not be disturbed in fixing the seniority:**

**Provided further that in the case of two or more members appointed on the same date, their seniority shall be determined as follows:-**

**(a) a member appointed by direct recruitment shall be senior to a member appointed by promotion or by transfer;**

**(b) a member appointed by promotion shall be senior to a member appointed by transfer;**

**(c) in the case of a member appointed by promotion or by transfer, seniority shall be determined according to the seniority of such members in the appointments from which they were promoted or transferred; and**

**(d) in the case of members appointed by transfer from different cadres, their seniority shall be determined according to pay, preference being given to a member, who was drawing a higher rates of pay in his previous appointment; and if the rate of pay in his previous appointment; and if the rates of pay drawn are also the same, then by the length of their Service in the appointments and if the length of such Service is also same, the older member shall be senior to the younger member.**

It is clear from the above mentioned rules that seniority is determined on the basis of length of services. So, the teacher who were promoted earlier than the petitioners have to be placed prior to the petitioners in the seniority list.

Further, the seniority of candidates whose services have been regularized with effect from 01.10.2003 in compliance of regularization policy dated 01.10.2003, also been fixed as per their date of regularization. As per regularization policy dated 01.10.2003. The operative part of policy is as under:-

**"The seniority of adhoc/contractual or daily wages employees so regularized vis-à-vis the Group-C and Group-D employees shall be determined with effect from 1st October, 2003. The inter-se-seniority of such adhoc/contract or daily-wages Group-C and Group-D employees shall be determined in accordance with the date(s) of their joining the post on adhoc/contract or daily wage basis. If the date of joining the post on adhoc/contract or daily wage basis by such adhoc/contract or daily wage employee is the same, then an older employee shall rank senior to an employee younger in age. If the date of appointment of the direct recruit and the date of regularization of adhoc/contract or daily wage employee is the same, the direct recruit shall be senior."**


Hence, the teachers who were regularized under regularization policy dated 01.10.2003 have to be placed prior to the petitioners as they were

*He*

regularized w.e.f. 01.10.2003 and joined the services prior to the petitioners. In addition to this, inter se seniority of such regularized teachers have been considered from the date of joining on adhoc basis as per regularization policy dated 01.10.2003. Mere selection itself is no right for appointment. Seniority is to be taken from the date when the person is given appointment. Seniority is to be reckoned not from the date when vacancy arose but from the date on which the appointment is made to the post. Retrospective seniority should not be granted from a day when an employee is not even borne in the cadre so as to adversely impact those who were validly appointed in the meantime.

Keeping in view the facts enunciated above and documents on record, the claim of petitioners for fixation of their seniority above and over the teachers who were promoted or regularized in the year-2000-2004 are not tenable & the same is hereby rejected being devoid of merits.

It is ordered accordingly.




