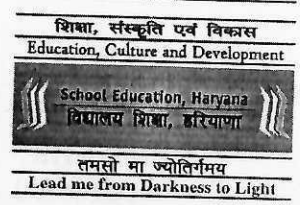

Terms and Conditions

1. This promotion is subject to final outcome of CWP No. 22560 of 2023 titled as Shiv Kumar and others V/s State of Haryana and others.
2. These promote(s) will remain on probation for a period of one year as per rule 27 of Haryana Civil Services (General) Rules, 2016 and which can be extended if their services are not found satisfactory.
3. The inter-se-seniority of the promote(s) shall be subject to the claim of their seniors, who have not been promoted in these order due to various reasons and for whom the posts have been kept reserved.
4. If any officer is found senior to these officers at any stage due to re-fixation of seniority in feeder cadre, they shall be reverted without giving any notice.
5. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the officer shall be reverted in view of the C.S. instruction dated 31.05.2006, without issuing any notice.
6. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
7. The promotion is subject to the condition of pending ACRs mentioned against the name of the officers and if anything found adverse regarding their integrity in their ACR they will be reverted without giving any notice.
8. If subsequently any senior person becomes eligible for promotion due to availability of ACRs/APARs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
9. They are directed to join their place of posting within 7 days and sent relieving/Joining report to the Directorate accordingly. Further, if he/she is not willing to accept this offer of promotion on the above terms and conditions, he/she should submit his/her representation regarding forgo of promotion to the Directorate within stipulated period.
10. That the following officer(s) are not being promoted/upgraded as Deputy District Education Officer as they have opted to forgo promotion. Their case will be considered for promotion after a period of one year.
