Whereas, Sh. Rambir Singh has filed CWP No. 32876 of 2024 titled as Rambir Singh vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to quash impugned rejection letter dated 06.02.2023, whereby case of petitioner for promotion to the post of PGT Physical Education has been illegally rejected against the rules and direct to promote the petitioner to the post of PGT Political Science or Physical Education w.e.f. the date of promotion of the juniors of petitioner.

The Hon'ble Punjab & Haryana High Court disposed of the said petition on dated 27.01.2025 with following orders:-

"The petition has been filed inter alia seeking a writ of mandamus directing the respondents to consider the petitioner for promotion as PGT Physical Education or Political Science in accordance with the rules.

2. Ms. Tanushree Gupta, DAG, Haryana, appearing on advance notice, on instructions received from the second respondent/Director, Secondary School Education Department, vide memo, dated 27.01.2025, contends that the petitioner's case for promotion is under active consideration of the Department, and the same will be decided by the first respondent/Additional Chief Secretary, School Education Department, by passing a speaking order thereupon in accordance with law within a period of eight weeks.

3. In view of the statement made, learned counsel for the petitioner has no objection to the petition being disposed of in terms thereof.

4. Ordered accordingly.

5. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of 50,000 to the petitioner."

Whereas, in compliance of the above said order, the promotion case of the petitioner has been examined and it is found that Sh. Rambir Singh is claiming promotion to the post of PGT Physical Education or its alternative to the post of PGT Political Science w.e.f. 06.12.2006.

In regard to the claim for promotion to the post of PGT/Lecturer Political Science. The Department sought promotion cases in the year-2007 followed by another call for promotion in the year-2009.

As per the Haryana State Education School Cadre, (Group C) Service Rules, 1998, the requisite qualifications for the post of Political Science are here as under:-

By promotion:-

- (i) **M.A. Political Science with atleast 50% marks and B.Ed from recognised university; AND**
- (ii) **2 years teaching experience as TGT Social Study; AND**
- (iii) **Certificate of having qualified Haryana Teacher Eligibility Test (HTET)/School Teachers Eligibility Test (STET).**

However, such promotion cases were of those C & V Teachers/Masters who were appointed on regular basis upto 31.12.1991, the petitioner was appointed as PTI on contract basis on 20.09.1994 under SC Category and he was appointed on regular basis on 29.09.1995. Hence, he could not be promoted w.e.f. 2007 or 2009 as he was not within the seniority upto which the teachers were promoted to the post of Lecturer Physical Education.

Whereas, thereafter, the department sought promotion cases to the post of PGT/Lecturer Political Science vide letter dated 09.11.2011. However, promotion under this letter dated 09.11.2011 were not made as new rules for promotion/appointment as Haryana State Education School Cadre, (Group-B) Service Rules, 2012 were to be introduced. These rules were notified vide notification dated 11.04.2012, the requisite qualifications for the post of PGT/ Lecturer Political Science are here as under:-

By promotion:-

- (i) **M.A. Political Science with atleast 50% marks and B.Ed from recognised university; AND**
- (ii) **2 years teaching experience as TGT Social Study; AND**
- (iii) **Certificate of having qualified Haryana Teacher Eligibility Test (HTET)/School Teachers Eligibility Test (STET).**

As per the Rule the petitioner must be having 2 years teaching experience as TGT Social Studies for promotion to the post of PGT Political Science. However, the petitioner was working as PTI. Hence, he was not eligible for promotion to the post of PGT Political Science.

In regard to the claim of the petitioner for promotion to the post of PGT Physical Education. As per the Haryana State Education School

Cadre, (Group B) Service Rules, 2012, the requisite qualifications for the post of Physical Education are here as under:-

By promotion:-

- (i) **M.A. Physical Education with atleast 50% marks and B.Ed from recognised university;**
- (ii) **2 years teaching experience as TGT Physical Education/ Physical Training Instructor (PTI);**
- (iii) **Certificate of having qualified Haryana Teacher Eligibility Test (HTET) /School Teachers Eligibility Test (STET).**

As per above said rules, the petitioner must have M.A. in Physical Education from recognized university for promotion to the post of PGT Physical Education but the petitioner did not fulfill the requisite qualification for promotion to the post of PGT Physical Education because he has obtained his Master Degree from Institute of Advanced Studies in Education University, Gandhi Vidhya Mandir, Sardarshar (IASE), Rajasthan. However, the Institute of Advanced Studies in Education University, Gandhi Vidhya Mandir, Sardarshar (IASE), Rajasthan being Deemed University, is not competent to run the distance education programme beyond their territorial jurisdiction without the permission of State Government and University Grants Commission. Whereas, this University did not take permission from the State Government and University Grants Commission before opening study center to run distance education programme. In absence of the permission of University Grants Commission and State Government wherein study centers are located, the degrees obtained from such study centers by the candidates are not legal and such candidates are not eligible for promotion as Post Graduate Teacher in Haryana Government Services.

Whereas, the issue with regard to promotion from TGTs to PGTs who obtained their post graduate degree from the deemed to be universities is sub-judice before the Hon'ble Division Bench in LPA No. 19 of 2021 titled as State of Haryana and other vs. Shri Bhagwan against the order of Single Bench dated 16.10.2019 in CWP No. 15843 of 2018 titled as Shri Bhagwan vs State of Haryana and others, wherein LPA was listed before the Division Bench on 26.02.2021 and the stay was granted by the Hon'ble Division Bench.

Whereas, the petitioner has given the example of his junior namely Sh. Balwan Singh who was appointed as C & V Teacher vide order dated

fu

30.04.1998 and was promoted on the post of PGT/Lecturer Hindi vide order dated 07.10.2003. That the junior who is exampled by the petitioner was promoted on the post of PGT/Lecturer Hindi which is a different cadre than PGT/Lecturer Physical Education. No person junior to the petitioner were promoted to the post of PGT/Lecturer Physical Education.

In view of the facts mentioned above, the claim of Sh. Rambir Singh is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.
