She often fight with colleagues & abused them loudly in-front of students. Students filed a number of complaints against her alleging that she did not know how to teach Economics.

Further, undersigned visit the Govt. Sr. Sec. School, Sector-6 (Panchkula) on 27.07.2023 from 9:30 A.M. to 11.00 A.M. At that time you were sitting in Class IX B. In this class the period of Maths was to be taken by Mr. Jogesh Arora but he was on training at DIET Panchkula. So, you were sent in Class IX B as an adjustment. When undersigned asked why are you sitting idle, you bluntly told that I can't teach Maths because I am teacher of Economics."

Whereas CBC Memorial School, Barwala, Hisar was granted permanent recognition for 9th to 10th level vide order no 26/92-07 PS(4) dated 28.03.2008 by Director Secondary Education Haryana, Panchkula.

Whereas Sudhir Noor & Ors made complaints against CBC Memorial School, Barwala, Hisar alleging therein that the students were admitted under the CHEERAG Scheme in CBC Memorial School, Barwala but the said school has been charging fee from the parents. Further, it has been stated that the school has refused to issue School Leaving Certificates (SLCs) when requested and that caste-based abusive language has been used against the complainants.

The District Education Officer, Hisar submitted her report vide letter no G-I/2024/901 dated 13.05.2024. In the report it is mentioned that CBC Memorial School, Barwala was directed on 06.05.2024, 07.05.2024 and 08.05.2024 through written communication letter by the Block Education Officer, Barwala, Hisar to appear in the office with the school records. However, the concerned Principal neither appeared in the office nor submitted the required records. It has been recommended that recognition of the said school may be withdrawn as per the rules.

Whereas, CBC Memorial School, Barwala, Hisar was granted permanent recognition on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

The Rule 158 (2) of Haryana School Education, 2003 provides that the procedure for collecting fee in a recognized school shall be open, transparent and accountable. The fee shall be collected from students through cheque/DD/RTGS/NEFT/any other digital mode of payment. That the CHEERAG Scheme (Chief Minister Equal Education Relief, Assistance, and Grant - CHEERAG) has been launched by the Haryana Government with the



objective of providing quality education to students from the Economically Weaker Section (EWS). Under this scheme, the state government grants free admission to EWS category students in selected private schools to ensure they receive better educational opportunities.

The said school is demanding fees from students admitted under the CHEERAG Scheme, despite the policy mandating free education for eligible students. Parents are being pressurized to pay fee in violation of the guidelines. The issuance of School Leaving Certificates (SLCs) is governed by the Haryana School Education Rules, 2003. Specifically, Rule 139(1) stipulates that no recognized school shall admit a student from another recognized school without an SLC. This rule underscores the mandatory nature of the SLC for student transfers to other schools still the school is not issuing SLC to students.

Whereas Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution
(2) The recognition/NOC of the school shall lapse if the school,-

(a) XXXX

(b) XXXX

(c) XXXX

(d) XXXX.

(e) has not complied with one or more of the conditions of recognition, specified in these rules.

Therefore, a show cause notice is being issued to the school management of the said school as to why the recognition granted to the school may not be withdrawn Rule 42 of the Haryana School Education Rules, 2003.
