

Sanction of the Govt. of Haryana is hereby accorded to grant a sum of **Rs. 3,37,500/- (Rs. Three Lacs Thirty Seven Thousand Five Hundred Only)** as Medical Advance to **Sh. Krishan Lal [206995], PGT Economics, Govt. Sr. Sec. School, Samana Bahu (Karnal)** to meet expenditure in connection with treatment of himself at **Indus International Hospital, Derabassi (Punjab)** in relaxation of Punjab/ Haryana services Medical Attendants Rule, 1940 subject to the following conditions:-

1. The Govt. will bear the expenditure spent on indoor treatment medicines/Hospital charges only.
2. The amount of medical advance will be adjusted according to the Medical rules. The adjustment of amount will have to be done within three months otherwise will be penalized with interest according to instructions.
3. The advance payment should not be considered that the Medical Bill has been granted. It will be seen on examining the case whether the amount will be adjusted or it is to be recovered.
4. The adhoc employee/officer will not given Medical advance if an official/employee is temporary then he will have to given surety of permanent officer/employee. A retired officer/official will be required to furnish surety of two permanent officers/official for getting the medical advance.
5. The payment of Medical **Rs. 3,37,500/- (Rs. Three Lacs Thirty Seven Thousand Five Hundred Only)** shall be made within 15 days before the date of operation.
6. Advance is allowed subject to the condition that the admissible bill amount will not be less than the advance amount.

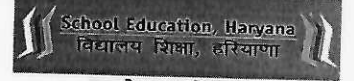



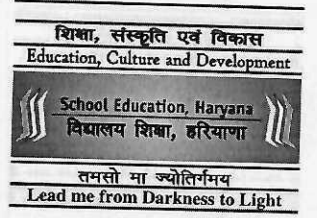
