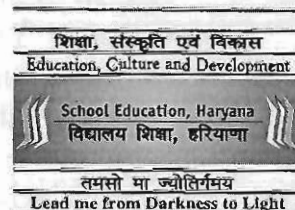

In compliance of orders dated 15.05.2025 passed by the Hon'ble Punjab & Haryana High Court, Chandigarh in CWP No No. 8878 of 2025 titled as Gaytri Vs State of Haryana and others and in pursuance with instructions of Chief Secretary, Haryana issued vide No. 22/10/2013-IGS-III dated 01.07.2022 & 11.07.2023 and amended from time to time, Smt. Gaytri [204681], (Seniority No. 198-A of PGT Divyang as stood on 08.07.2023), Post Graduate Teacher in Sociology, Government Senior Secondary School, Barauli [2074] (Panipat), (Disability Category [HH]) is hereby granted deemed date promotion to the post of Principal (Rest of Haryana Cadre) (School Cadre) w.e.f. 15.06.2022 (under 4% reservation in RPwD Quota) in the pay scale of Rs.15,600-39,100 + 6600 (G.P.) with benefit of notional pay fixation although she is not entitled for arrears for the period in which she has not actually worked as Principal). On promotion, she is hereby posted at Govt. Sr. Sec. School Chandoli [2147] (Panipat) against vacant post subject to the condition that she will participate in the next General Transfer Drive, as per following terms & conditions:-

1. In case the claim belonging to disability certificate of any employee is found false and fabricated at any stage later on, he/she would be reverted without any notice and without any prejudice to such further disciplinary action as may be initiated under the provision of the Indian Penal Code for production of such false/fabricated documents.
2. The Roster point allotted to the aforesaid officers is provisional and can be changed/amended/alterd, if required on the basis of any legitimate claim of some other or any of the PGTs in the cadre.
3. In addition to these candidates, if claim of another Divyang PGT is found legitimate in respective category, the junior most would be reverted without a notice and concerned senior disabled PGT would be considered.
4. There should be no charge sheet under Rule-7/8 of HCS (Punishment & Appeal) Rules, 2016 and vigilance enquiry pending against the above mentioned officials as on date on the promotion/deem date promotion.
5. The above promotions/deem date of promotion is subject to the condition that if any adverse remarks are found later on in the ACR's which are not presently available in the office records, the officials concerned will be reverted back immediately, without assigning any reasons.
6. That above promotion/deem date of promotion is found senior to the officials being promoted junior most will be reverted without assigning any reason.
7. That this promotion is being made effected on the basis of provisional seniority list of Divyang PGTs and any change in the list may result in reversion of an official if it is found that a person senior to him has been left out for want of certain information/record.
8. That this promotion is without prejudice to the right of his senior if any who have been ignored for want of certain information/record.
9. That the official should not be relieved/joined on promotion post during the currency of the stoppage of grade increment(s).
10. That the official should not be relieved/joined on promotional post without checking their Unique Disability Identity Card issued by the Govt. of India. Only permanent Disability Card accepted.
11. The above promotion is subject to the final outcome of CWP No. 21481 of 2019 titled as Prahlad Singh Vs State of Haryana, 2631 of 2021 titled as Shamsher Singh Khatri Vs State of Haryana, CWP No. 2607 of 2021 titled as Sunder Lal Vs State of Haryana, CWP No. 6245 of 2018 titled as Krishan Kumar Vs State of

- Haryana, 10934 of 2022 titled as National Blind Association Vs State of Haryana 29326 of 2019 titled as Surender Vs State of Haryana & CWP No. 9975 of 2022 titled as Vijay Kumar Jindal & Others, CWP No. 18639 of 2024 titled as Dr. Vijender Singh Vs State of Haryana and others.
12. The candidate will not claim any arrear of pay on account of his/her notional promotion and only notional benefits of pay fixation will be granted. He/She would be granted actual benefit of pay fixation from actual date of joining of promotional post.
 13. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the Haryana State Education School Cadre (Group-B) Service Rules, 2012 amended in 2014, the said incumbent(s) shall be reverted without issuing any notice.
 14. He/She will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.
 15. After promotion, seniority of these officers will be determined as per instructions rules issued or notified by the Govt. of Haryana, School Education Department from time to time.
 16. He/She have to seek permanent posting through One School portal by participating next Transfer Drive.
 17. The promotions under these instructions have been granted to the persons with disabilities who may be junior to others in the seniority list. No benefit of stepping up of pay or pay scale shall be admissible to others who were/are senior to him/her in the PGT Cadre.
