6. The school management has assured that a neutral and harmonious environment will be provided for all students.
7. The school shall ensure compliance with all directions issued from time to time by CBSE/HBSE and the Directorate of Secondary Education, Haryana, Panchkula.

In view of the above, it is ordered that the school must exercise due diligence to avoid recurrence of such incidents in the future and maintain a conducive and secure learning atmosphere for all students. The complaint is now considered resolved and the case is closed.
