SHOW CAUSE NOTICE

Order No.6/114-2024 PS (4)

Whereas, Vats Vidya Mandir, Yakubpur, Jhajjar was granted permanent recognition 11th to 12th level vide order no. 14/30-2014 PS(3) dated 10.02.2016 by the Director Secondary Education, Haryana, Panchkula.

Whereas a complaint was received against Vats Vidya Mandir, Yakubpur, Jhajjar from Sh. Hemant Kumar Vats, H.No. 131. Ganpati Enclave, Paprawat Road, Najafgarh, New Delhi through Hon'ble Education Minister alleging distortion and use of deceitful means in obtaining a NOC from Directorate of School Education, Haryana.

Whereas, the District Education Officer, Jhajjar was directed vide memo No. 6/114-2024 PS (4) dated 26.07.2024 to conduct an enquiry in this matter and submit its report. That in compliance of letter No. 6/114-2024 PS (4) dated 26.07.2024 the District Education Officer, Jhajjar submitted her report vide letter no G-4-24/9180 dated 28.08.2024. In the report it was submitted the lease deed no 3647 dated 29-01-2003 has actually been cancelled on 09-01-2004 vide deed no 3375. All certificates, lease deed have different area and difference in kila numbers, lease deed no 3647 which has been cancelled may have been used in obtaining NOC. In inspection proforma dated 30-07-2014 the names of lessors of land area of 24 kanal 4 marla and also 28 kanal 7 marla mentioned in the same proforma are -Ishwanti w/o Braham Prakash, Dinesh Kumar s/o Jagdish Rai, Arun Kumar s/o Sh Jagdish Rai and Braham Prakash s/o Sh Amar Singh. Whereas Ishwanti and Braham Prakash have sold their land to Dinesh Kumar and Arun Kumar vide registry no 4097 dated 18/03/2004. They cannot be lessors of the same land now in 2014 and the considered opinion that some facts related to land may have been misrepresented for taking NOC. The complaints and President of Society are real brothers and are co-owners of the land. This facts has been stated by the President itself in written reply. The documents attached with the NOC file may be procured and should be re-examined for accurate information.

Whereas, the trust/management has made itself liable for punitive action under Rule 43 (1) of the Haryana School Education Rules, 2003. The rule 43 provides for suspension or withdrawal of recognition/ N.O.C of the school where management committee of school has obtained recognition by fraud. Rule 43 (1) of the said Rules is reproduced here as under:-

*"43. (1) The appropriate authority may withdraw/ suspend the recognition/NOC** of a school after giving a reasonable opportunity against the proposed action to be taken against the school in the following circumstances:-*

(a) xxxxxxxxxxxx

(b) xxxxxxxxxxxx

(c) if the managing committee of the school obtains recognition/NOC by fraud, mis-representing or suppressing any particulars or after obtaining recognition/NOC* fails to continue to comply with any of the conditions specified in these rules the appropriate authority after giving a reasonable opportunity and one month notice to show cause against proposed action can withdraw recognition/NOC**

(d) xxxxxxxxxxxx

Therefore, in exercise of power conferred upon me under Rule 43 (1) of the Haryana School Education Rules, 2003, a show cause notice is being issued to the school management to show cause as to why the recognition/NOC granted to their school may not be withdrawn from the next academic session.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules.
