Whereas Mr. Anil Kumar, father of Ms. Hina & others made a complaint received via email dated 16.04.2024, against Brahm Dutt Blue Bells Public School, Sector-10, Gurugram, Haryana alleging therein that the students were admitted under the 134-A Scheme in Brahm Dutt Blue Bells Public School, Sector-10, Gurugram but the said school has denied admission to such students in Class 11, despite the fact that she was studying in Class 10 under Rule 134-A in the said school.

Whereas, the District Education Officer, Gurugram was directed vide memo No. 8/51-2025 PS (1) dated 17.04.2025 to conduct an enquiry in this matter and submit its report. In this report it is submitted that the school has repeatedly refused admission while referring to the judgment of the Hon'ble Punjab and Haryana High Court in CWP No. 6980 of 2016. It has further been informed that the school has not complied with any directions issued by the DEO as of 22.04.2025. That as per the notification dated 28.03.2022, although Rule 134-A has been omitted, but students already admitted under this Rule/scheme shall continue and complete their education in the same recognized private schools.

Whereas, Brahm Dutt Blue Bells Public School, Sector-10, Gurugram was granted permanent recognition on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

Whereas Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School

Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

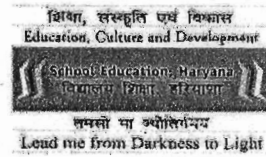

2. He/She will hand over his/her charge to the senior most teacher as the case may be before proceeding on leave.
3. He/She will bear all the expenses on the said tour from his/her own pocket and the State would not bear any expense incurred by him/her.
4. He/She will not accept any assignment by any Govt. or the NGO or anybody while on foreign visit.
5. He/She will not be doing any such activity which may be detrimental to the bilateral relations of India with the said country (s) being visited by him/her.
6. He/She will not be doing anything, which may be termed as detrimental to the sovereignty of India.
7. He/She will not be inviting any liability during his/her stay at abroad which may result into losses to Govt. in any manner.

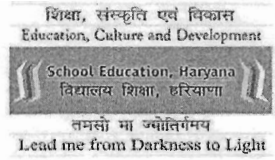
