Whereas, Smt. Usha Rani has filed Civil Writ Petition No. 13221 of 2025 titled as Usha Rani vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein for directing the respondent to allow the petitioner to join service as Post Graduate Teacher on the basis of appointment letter dated 03.04.2025 issued to her.

The case was listed for hearing on 23.05.2025 and the Hon'ble High Court has disposed of the case with the following directions: -

".....3. Learned State counsel, appearing on advance notice, contends that the petition itself is not maintainable since the petitioner never approached the respondents with the grievance raised herein. Therefore, she cannot be allowed to seek writ of mandamus.

4. In view thereof, at this stage, the petition is disposed of granting liberty to the petitioner to make an appropriate representation to the second respondent/Director, Secondary Education, within one week from today, which shall be decided keeping in view the undertaking given by the petitioner regarding her appointment, within four weeks therefrom."

In compliance of the above said orders, the representation dated 28.05.2025 of Smt. Usha Rani has been duly examined. She has prayed to kindly allow her to join as Post Graduate Teacher Mathematics in view of the appointment letter issued to her on 03.04.2025 subject to the condition of final outcome of 19876 of 2024 titled as Abhimanyu & others V/s State of Haryana & others.

Whereas, Smt. Usha Rani had applied for the post of Post Graduate Teacher Mathematics under Advertisement No. 28/2024 issued by the Haryana Public Service Commission and she was recommended by the Commission for the post of Post Graduate Teacher Mathematics.

Whereas, the qualifications for the said post are clearly laid down in the Haryana School Education (Group B) Service Rules, 2012:-

- (i) M.A./M.Sc. Mathematics/ applied Mathematics with Mathematics as one of the subject at Graduation level with at least 50% marks and B.Ed. from recognized university; AND**
- (ii) Matric with Hindi/Sanskrit or 10+2/B.A./M.A. with Hindi as one of the subject; AND**
- (iii) Certificate of having qualified Haryana Teacher Eligibility Test (HTET)/School Teachers Eligibility Test (STET).**
- (iv) Consistent good academic record.**



As per the said rules, the essential qualifications for the post of Post Graduate Teacher Mathematics is M.A./M.Sc. in Mathematics including certificate of having qualified the Haryana Teacher Eligibility Test (Level-III) for the concerned subject.

Whereas, it is an admitted fact that the petitioner, Smt. Usha Rani, does not possess the qualification of having cleared the Haryana Teacher Eligibility Test (**Level-III**) as required under the rules for appointment to the post of Post Graduate Teacher Mathematics.

Whereas, the petitioner, along with other similarly placed candidates, filed Civil Writ Petition No. 19876 of 2024 titled as Abhimanyu & others V/s State of Haryana & others before the Hon'ble High Court challenging the validity of Haryana Teacher Eligibility Test conducted by Board of School Education Haryana, Bhiwani in the year 2023 and for allowing such candidates to participate in ongoing selection process of Post Graduate Teacher Mathematics under the Advertisement No. 28/2024.

Whereas, Hon'ble High Court was pleased to pass interim order dated 14.08.2024 in the said writ petition, whereby the petitioner was provisionally allowed to participate in the selection process. The order dated 14.08.2024 is re-produced as under:-

“It is, inter alia, contended that the petitioners appeared for HTET 2023, wherein thirty questions of part II were out of syllabus. The respondent Board of School Education has accepted the mistake but followed the wrong procedure/method to evaluate the answer/OMR sheets. The decision has been challenged before this Court by filing different petitions, which are tagged along with CWP-9243-2024. Meanwhile, the Commission issued advertisement no. 18 to 37 of 2024 on 23.07.2024, inviting applications for the Post Graduate Teachers (PGTs) in various subjects. The posts have been advertised after a long gap of more than eight years. The petitioners are eligible for the same except for the qualification of HTET. In case they are not allowed to participate in the selection process, irreparable loss will be caused to them.

2. Notice of motion.

3. Mr. Ravinder Singh Budhwar, Addl. AG, Haryana, accepts notice of behalf of the respondents/State, and Mr. Kanwal Goyal, Advocate, accepts notice on behalf of respondent no.3. They seek time to file reply.

4. Adjourned to 23.08.2024.

5. In the meanwhile, the petitioners will be provisionally allowed to participate in the selection process. In case their application forms cannot be accepted online, the Secretary shall ensure hard copies of the same are accepted.”




However, it is clear that such participation shall not confer any right of appointment/joining on the petitioner.

Whereas, the final outcome of the selection process is governed by statutory rules and eligibility criteria as laid down therein. Since the Haryana Teacher Eligibility Test qualification is a mandatory requirement under the Haryana School Education (Group B) Service Rules, 2012, the petitioner cannot be considered for appointment/Joining in the absence of such qualification.

Therefore, in light of the above facts and legal position, and in adherence to the eligibility conditions prescribed under the statutory rules, the claim of Smt. Usha Rani for joining to the post of PGT Mathematics under Advertisement No. 28/2024 is hereby rejected, as she does not fulfill the essential qualification of having passed the Haryana Teacher Eligibility Test.

It is ordered accordingly.




