SHOW CAUSE NOTICE

Order No.6/110-2025 PS (1)

Whereas, O.S.D.A.B Public School, Kaithal was granted NOC vide order no. 31/8/90- V(4) dated 16.08.1990 by the Director General Secondary Education, Haryana, Panchkula.

Whereas a complaint was received against the O.S.D.A.B Public School, Kaithal from Deputy Commissioner, Kaithal and Via social media platform "Kaithal Prime TV" wherein, it was alleged that School Management is using the books of private publishers instead of NCERT books.

Whereas the District Education Officer, Kaithal submitted her report vide memo number G1/25/1731-38 dated 21.04.2025. In the report it was submitted that the school management is using the books of private publishers instead of NCERT books in school.

Whereas the Director Secondary Education Haryana vide its memo no. 8/27-2020 PS (2) dated 06-05-2021 has issued directions for prescribing only NCERT Books in all private recognized schools in the state of Haryana. Furthermore Department of Education has also amended the Haryana School Education Rules 2003 vide notification dated 08-12-2021. Amended Rule 158 (6) states as under:-

"No student shall be compelled to purchase books, note books, workbooks stationary, shoes, socks, uniform etc only from a shop recommended by the recognized school."

Whereas the said school has violated the above mentioned statutory rules by prescribing books other than NCERT/ Private publishers books and by compelling the students to buy books etc from a shop recommended by the school management.

Whereas, Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School

Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution
(2) The recognition/NOC of the school shall lapse if the school,-
 (a) XXXX
 (b) XXXX
 (c) XXXX
 (d) XXXX.
 (e) has not complied with one or more of the conditions of recognition, specified in these rules.

Therefore, a show cause notice is being issued to the school management of the said school as to why action may not be taken against the school management under Haryana School Education Rules, 2003.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules.
