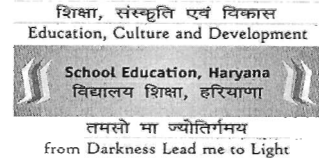

**ORDER**



In compliance of order dated 22.04.2022 passed by the Hon'ble High Court in CWP No. 8188 of 2022 and on the recommendation of Haryana Staff Selection Commission conveyed vide their Memo No. Confd./01/16/2023/683 dated 09.08.2023, the Governor of Haryana is pleased to appoint the following candidate as Post Graduate Teacher **Mathematics** (HES-II) (Rest of Haryana cadre) against Advt. No. 04/2015, Cat. No. 10 in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600 – 1,51,100/- plus usual allowances as admissible from time to time. She is directed to join at the place of posting as mentioned against her name as under:-

**Terms and conditions:-**

1. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. The benefit of notional pay fixation and seniority will be admissible w.e.f. 06.03.2019 from the date when his/her juniors have been appointed and actual financial benefits will be admissible to him/her from the date when he/she joins duty as PGT Mathematics.
3. The candidate shall have to take an oath of allegiance to the Constitution of India.
4. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
5. The candidate shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant

service rules and instructions of the State Government issued from time to time later on.

6. The candidate shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
7. In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate from issuing authority. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is found false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. The candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter educational qualification certificates be got verified from the issuing authority within 03 months. If in the verification it reveals that any certificate is found false then your appointment will be cancelled without any notice.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
11. The candidate shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
12. If at any time during the course of temporary appointment, the candidate desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
13. No TA/DA will be admissible to the candidate for joining as PGT.
14. If the candidate gets an appointment as PGT on the basis of furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, the candidate would be liable for termination of service without any notice.
15. This appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.



16. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in the self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provisional of Indian Penal Code (IPC) etc as deemed fit.
17. The said appointment are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within stipulated period. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in CS Haryana instruction No. 52/08/2022-3GS-III dated 23.06.2022 and 52/06/2018-2HR-III dated 05.02.2024.
18. The concerned candidate is directed to join duties at place of posting within 15 days and send the joining report (duly signed by DDO) at [dsepgt1@gmail.com](mailto:dsepgt1@gmail.com), failing which this offer of appointment letter will be deemed to have been withdrawn.

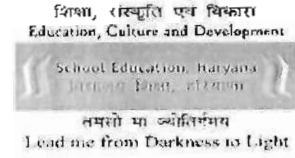

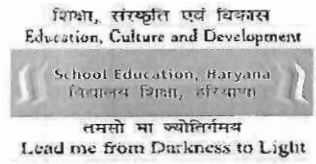

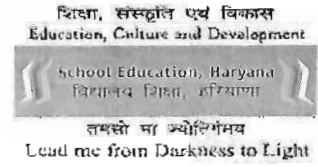

Whereas, the petitioner namely Sh. Chand Kishore [047259] was initially appointed as a JBT teacher on 12.03.1994 and thereafter promoted to the post of Science Master on 01.09.1997. Thereafter, he was selected as High School Headmaster and he joined on the said post on 01.02.2008 on experience basis. However, later on, the petitioner was placed under suspension vide order No. 5/24-2009 HRG-II(2) dated 05.04.2011 and a chargesheet under Rule-7 was served to him vide order No. 5/24-2009 HRG-II(2) dated 11.11.2011 with the following charges:-

1. That while working as Science Master at GGHS, Sonipat, he has given excessive corporal punishment to Ms. Suman a girl student of class 10th. This act of Sh. Chand Kishore was totally against the cannons of Conduct Rules and has shown irresponsibility to perform his duty in a decent manner especially his act of attacking the private organs of the girl student of a tender age was totally against the moral decency.
2. That he has stopped the salary of Smt. Shakuntla Devi, former Head Teacher, Govt. Primary School, Biswanmeel, Sonipat from May, 2010 to July, 2010 without specific and definite reasons and consequently, officers of the Department had to face the National Commission for Schedule Caste, Govt. of India, New Delhi.
3. That inspite of his transfer from GHS Biswanmeel (Sonipat) to Govt. High School, Barotha (Sonipat) on administrative grounds vide order No. 5/24-2009 HRG-II (2) dated 24.3.2011 and further on being relieved on the afternoon of 28.3.2011, he has not joined at the new station till 6.4.2011.

Whereas, a regular departmental inquiry was got conducted against the petitioner wherein the inquiry officer Sh. V.P. Batra, IAS (Retd.) submitted the enquiry report vide dated 20.09.2013 in which charges levelled against the petitioner were not found to be proved. However, the then PSSE was not satisfied with the said report and a dissenting note dated 31.10.2013 was issued against the petitioner. Thereafter, petitioner submitted the reply dated 04.12.2013 refuting all the contentions of dissenting note issued against him. After considering the reply of the petitioner, the then Principal Secretary Govt. of Haryana issued a show cause notice dated 27.02.2015 regarding dismissal of service of the petitioner with an opportunity to submit his representation in writing within 15 days of issuance of memorandum dated 27.02.2015.

Thereafter, the petitioner challenged the said order by way of filing the CWP No. 7164 of 2015 titled as Chand Kishore Vs. State of Haryana in the Hon'ble High Court, which was allowed by the Hon'ble High Court vide order dated 05.02.2025. The operative part of the order is as under:-

"Consequently, the writ petition is allowed, the impugned memorandum, dated 27.02.2015, is set aside. The respondents are directed to proceed with the matter and take a final decision in the disciplinary proceedings against the petitioner on the basis of enquiry report, dated 20.09.2013, without taking into account the dissenting note, dated 31.10.2013, which is illegal. The entire exercise shall be concluded by the first respondent/Financial

*Writ*

Commissioner and Principal Secretary to Govt. of Haryana, Department of School Education, within a period of three months of receiving a certified copy of the order."

Whereas, in compliance of the above said directions of Hon'ble High Court, petitioner was offered an opportunity of personal hearing on 23.07.2025 and during the course of hearing, the petitioner submitted his written representation praying therein that he has already been exonerated in inquiry dated 20.09.2013 and Hon'ble Court has also directed to decide disciplinary proceedings against him without considering the dissenting note.

Therefore, keeping in view the above said facts and circumstances enunciated above, finding of inquiry officer dated 20.09.2013, reply of charged officer to the dissenting note on 04.12.2023 and directions of the Hon'ble High Court dated 05.02.2025, the charge sheet against petitioner namely Shri Chand Kishore [047256], the then Head Master, Govt. High School, Beeswanwali Rai, Sonipat now posted at Govt. High School, Sitawali (Sonipat) is hereby dropped.

Whereas, Sh. Pawan Singh and Sh. Shiv Karan filed Civil Writ Petition No. 12641 of 2025 titled "Pawan Singh and another vs. State of Haryana & others" before the Hon'ble Punjab and Haryana High Court praying for a writ in the nature of certiorari seeking quashing of order dated 18.09.2024. Further, it was prayed that direction be issued to the respondents to make correction/revision in seniority list dated 2019 & 2024 as per date given in representation dated 16.12.2024 regarding correction of their seniority number in the seniority list and further direction be given to respondents to consider the cases of petitioners for promotion in-lieu of letter dated 13.03.2025.

The Hon'ble Punjab and Haryana High Court disposed of the said petition on 05.05.2025 with the following orders:

***"Notice of motion.***

***4. Ms. Tanushree Gupta, Deputy Advocate General, Haryana, accepts notice on behalf of the respondents/State and submits that the pending representation, dated 25.03.2025, will be decided by the second respondent Director, Secondary Education, by passing a speaking/reasoned order in accordance with law within a period of three months.***

***5. In view of the statement made, learned counsel for the petitioners has no objection to the petition being disposed of in terms thereof.***

***6. Ordered accordingly.***

***7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs.50, 000 to the petitioners."***

In compliance of the said order, the representation dated 25.03.2025 of Sh. Pawan Singh and Sh. Shiv Karan has been examined thoroughly. The petitioners have claimed for fixation of their seniority over and above the PGT/Lecturers English who applied for promotion alongwith them and over and above the PGTs/Lecturers who were directly appointed against Advertisement No. 6/2006.

The incumbents namely Sh. Pawan Singh and Sh. Shiv Karan were initially appointed as Science Masters on ad-hoc basis in the years 1995 and 1997 respectively. They were regularized on the said post on 01.10.2003. The department invited cases for promotion to the post of PGTs in various subjects in the year 2007. The petitioners alongwith other candidates applied for promotion to the post of PGT Physics. In pursuance to the said letter, promotions to different subjects were made on different dates i.e. PGT Chemistry on 05.11.2008, PGT Physics on 24.12.2008 with immediate effect



and English lecturers were promoted on 21.07.2009 who were given ante-dated promotion w.e.f. 25.10.2007.

During this period, the Haryana Staff Selection Commission, Panchkula had recommended vide dated 15.10.2008, the names of certain candidates for appointment to the post of PGTs in various subjects against Advertisement No. 6/2006 and appointments were offered to PGT English and PGT Hindi candidates after completion of all due courses vide orders No. 6/18-2008-HRL(4) dated 29.12.2008 and 07.01.2009.

The department published seniority lists of PGTs cadre in 2014. In the said seniority list, the petitioners were wrongly placed amongst the PGTs who were directly appointed against Advertisement 06/2006. Thereafter, the department published the seniority list of PGTs in the year 2019 and the petitioners were placed at appropriate place as per their promotion date and seniority in feeder cadre. In the said seniority list published vide order dated 08.07.2019, the petitioners were rightly placed after the directly recruited PGTs as per norms/instructions. Thereafter, seniority list of PGTs cadre was again published vide order dated 04.09.2024 after considering objections.

Whereas, in regard to Seniority, Rule 11(1) of 'Haryana State Education School Cadre (Group- B) Service Rules, 2012' provides as under:-

**11. (1) Seniority, inter se of the members of the service, shall be determined by the length of continuous service on any post in the service:**

***Provided that where there are different cadres in the service, the seniority shall be determined separately for each cadre:***

***Provided further that in the case of a member appointed by direct recruitment the order of merit determined by the recruiting agency shall not be disturbed in fixing the seniority:***

***Provided further that in the case of two or more members appointed on the same date, their seniority shall be determined as follows:-***

***(a) A member regularized shall be senior to a member appointed by promotion or by transfer;***

***(b) A member appointed by promotion shall be senior to a member appointed by transfer;***

***(c) In the case of member appointed by promotion or by transfer, seniority shall be determined according to the seniority of such members in the appointments from which they are promoted or transferred; and***

***(d) In the case of members appointed by transfer from different cadres, their seniority shall be determined according to pay, preference being given to a member, who was drawing a higher rate of pay in his previous appointments, and if the rates of pay drawn are also the same, then by the length of their service in the appointments and if the length of such***

*mu*

***service is also same, the older member shall be senior to the younger member.***

As per the Government of Haryana order No.13/5-2015 PGT-II (3) dated 05.04.2017, in case of any direct recruitment where the recruitment process was initiated through a common advertisement issued by the recruitment agency for all subjects on a single date, then all lists of recommendations, originating from such integrated recruitment process, regardless of the date of recommendation or joining, have been allocated a common place in the inter se seniority prepared. A single integrated recruitment process has been treated as single integrated recruitment notwithstanding any difference in the date of recommendation/date of appointment order/date of joining. Upon careful examination of the facts, documents, and applicable rules, it is found that the recruitment process was initiated by common Advertisement 06/2006 dated 20.07.2006. All lists of recommendations, originating from such integrated recruitment process, regardless of the date of recommendation or joining, have been allocated a common place in the inter se seniority prepared, including PGT English and PGT Hindi candidates even though they were appointed after completion of all due courses vide orders No. 6/18-2008-HRL (4) dated 29.12.2008 and 07.01.2009, which was beyond the date of promotion of the petitioners. However, these PGT English and PGT Hindi were placed along with other candidates of Advertisement 06/2006 dated 20.07.2006 above the petitioners as per the Government of Haryana order No.13/5-2015 PGT-II (3) dated 05.04.2017. The petitioners cannot be placed above the PGT English promoted vide order dated 21.07.2009 as these were given ante-dated promotion w.e.f. 25.10.2007 and hence placed above the petitioners as petitioners were promoted on 24.12.2008.

The grounds for rejection of the petitioners' claim are that during the fixation/rectification of seniority list of PGTs, the seniority of the petitioners has been rightly fixed in the seniority list 2019 and the same is reflected in the seniority list dated 04.09.2024 as per existing instructions/rules/policy. The seniority has been fixed in accordance with Rule 11(1) of 'Haryana State Education School Cadre (Group- B) Service Rules, 2012' and Government of Haryana order No.13/5-2015 PGT-II (3) dated 05.04.2017. The department had already corrected the anomaly in the 2014 seniority list and properly placed the petitioners in the 2019 seniority list as per their promotion date and seniority in feeder cadre. The petitioners have failed to demonstrate any legal basis or justification for further revision of their seniority, which has already been fixed correctly as per applicable rules and instructions.


Keeping in view the facts enunciated above and documents on record, it is observed that seniority of the incumbents has already been rightly

*ju*

fixed by the respondent department as per the existing rules/instructions/policy and the incumbents cannot be entitled for the re-fixation of their seniority as prayed in the representation dated 25.03.2025 submitted by them. The petitioners' claim lacks merit both in law and on facts. The seniority list has been prepared in accordance with statutory rules and government instructions, and any further revision would be contrary to the established legal framework.

Therefore, the claim of incumbents namely Sh. Pawan Singh and Sh. Shiv Karan in their representation dated 25.03.2025 regarding necessary corrections in the seniority list of Post Graduate Teachers is not tenable and is hereby rejected being devoid of merits.

It is ordered accordingly.

**Terms & Conditions:-**

1. These promotions are made in compliance of Hon'ble High court order dated 06.02.219 in CWP No. 13160 of 2016.
2. If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without any prior notice.
3. The District Education Officer concerned will ensure that no disciplinary proceedings U/R 7 or punishment of stoppage of annual increment is pending against the promoted PGTs. If any employee allowed to join with disciplinary proceedings pending, the DEO concerned will be fully responsible for the laxity.
4. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the instructions dated 31.05.2006, enunciated above, without issuing any notice.
5. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
6. The benefit of notional pay fixation and seniority will be admissible to the concerned promotee w.e.f. 06.05.2016 from the date when his juniors have been promoted and actual financial benefits will be admissible to him from the date when he joins as PGT Punjabi.
7. If subsequently, it is found that candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of Division Bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
8. The promotion being based on provisional list and without prejudice to the right of the seniors to be considered if they opt for promotion as PGT provided they are found eligible for the post.



9. Promotions are subject to undergo change if warranted on the regularization of the provisional gradation list.
10. In case the degree of a teacher is found not to be from a recognized University having no statutory authority/jurisdiction in regard to award of such degree, the promotion shall be cancel forthwith and the teachers so promoted shall be liable for strict disciplinary action.
11. The teachers in the provisional seniority list who are senior to the teachers whose documents have been found in order and eligible are being promoted and posts have been reserved for them pending determination of their eligibility at a later date.
12. Inter se seniority based on the feeder cadre shall be the determining factor in the PGT Cadre. In other words if a senior employee in the TGT cadre is found eligible at a later date and vacancy in respect of him is occupied by a junior employee then the junior employee shall have to be reverted back so that such senior employee may get his due promotion.
13. It is also made clear that the candidates can't be considered senior then other TGTs those will be promoted thereafter in other subjects and seniority will be considered only from their feeder cadre i.e. as per seniority list of TGTs.
14. The Head of Institution shall ensure compliance of above conditions before letting the promoted teachers to join.
15. If subsequently any senior person becomes eligible for promotion due to availability of ACRs or other records, then in that eventuality, he shall be treated as senior, though promoted later on, to the earlier promoted junior candidate of a specific cutoff date of eligibility.
