ORDER

No. 13/246-2024 PGT-I (1)

Whereas, Sh. Rajesh Kumar (Employee ID: 051096), filed CWP No. 28881 of 2024 titled Rajesh Kumar vs. State of Haryana & Others before the Hon'ble Punjab and Haryana High Court, seeking directions to the respondent department to promote him to the post of PGT English from the date on which his juniors were promoted. He further requested that his representation dated 22.02.2024, submitted in this regard, be decided expeditiously.

The case was listed for hearing on 13.11.2024 and the Hon'ble High Court has disposed of the case with the following directions: -

"...Notice of motion.

4. Ms. Tanu Shree Gupta, Deputy Advocate General, Haryana, accepts notice on behalf of the official respondents and submits that the pending representation, dated 22.02.2024, will be decided by respondent No.2/ Director, Secondary Education, by passing a speaking order in accordance with law, within a period of three months.

5. In view of the statement made, learned counsel for the petitioner has no objection to the petition being disposed of in terms thereof.

6. Ordered accordingly

7. In case the order is not passed within the stipulated period, the officer concerned shall pay cost of Rs. 50,000 to the petitioner"

In compliance with the orders of the Hon'ble Court, the petitioner's representation dated 22.02.2024 has been examined. As per official service records, Sh. Rajesh Kumar was initially appointed as PTR/JBT on 10.11.1991. He was promoted as TGT Mathematics on 13.09.2001 and later promoted to the post of ESHM on 24.08.2019. The petitioner is now claiming promotion to the post of PGT English with retrospective effect from 13.04.2022, contending that some of his juniors were promoted to the said post on that date.



Whereas, as per Haryana State Education School Cadre Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualifications for promotion to the post of English PGT (Post Graduate Teacher) from TGT English (Trained Graduate Teacher) is as under:-

By promotion:-

- i. **M.A. English with at least 50% marks and B.Ed. from recognized university; AND**
- ii. **2 years teaching experience as TGT English; or
Two years experience of teaching English in case of TGT Social Studies having English as an Elective subject in Graduation.**

The cut-off date for consideration of promotion cases through proper channel was fixed as 30.11.2021. The Departmental Promotion Committee (DPC) meeting to scrutinize the cases for promotion was held on 12.01.2022, and subsequently promotion orders were issued on 13.04.2022.

At the time of the cut-off date, the petitioner did not possess the required two years of teaching experience as TGT English. He was working as TGT Mathematics and thus did not fulfill the prescribed eligibility conditions under the applicable service rules. In contrast, the juniors who were promoted to the post of PGT English on 13.04.2022 were found eligible as they met all the requisite qualifications and experience criteria as of the relevant date.

Upon detailed scrutiny of the petitioner's academic and service credentials, it has been observed that while he may possess the academic qualifications of M.A. (English) and B.Ed., he has never been appointed or posted as TGT English during his service tenure. Rather, he has served in the capacity of TGT Mathematics. As such, he does not fulfill the essential requirement of having two years of teaching experience specifically as TGT English, as mandated by the service rules for eligibility to the post of PGT English.

In view of the above facts and in accordance with the provisions of the Haryana State Education School Cadre (Group-B) Service Rules, 2012 (as amended), it is clear that the petitioner, Sh. Rajesh Kumar, does not fulfill the essential eligibility criteria for promotion to the post of PGT English. Specifically, he lacks the

mandatory two years of teaching experience as TGT English required for consideration of promotion to the post of PGT English. The juniors who were promoted possessed the requisite qualifications and teaching experience as per the service rules, and their promotions were rightly processed and issued. Furthermore, Sh. Rajesh Kumar has already been promoted to the post of ESHM from the post of TGT Mathematics on 24.08.2019. Hence, no longer a part of TGT Cadre in the year-2022, when promotion were made from TGTs to the post of PGT so question of his promotion to the post of PGT does not arise.

In view of the facts mentioned above, the claim of Sh. Rajesh Kumar is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.

2. If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending. Subsequently, the said incumbent (s) shall be reverted without issuing any notice.
3. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
4. If subsequently, it is found that he/she has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of division bench judgment of Punjab and Haryana High Court in CWP No. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
5. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.05.2006.

6. If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
7. These promotion order is based on provisional seniority list and without prejudice to the right of the seniors to be considered if they opt for promotion as **PGT (Hindi)** provided those seniors are found eligible for the post.
8. In case the degree of a teacher is found not to be from a recognized University having no statutory authority/ jurisdiction in regard to award of such degree, the promotion shall be cancelled forthwith and the teachers so promoted shall be liable for strict disciplinary action.
9. The teachers in the provisional seniority list who are senior to the teachers whose documents have been found in order and eligible are being promoted and, posts have been reserved for them pending determination of their eligibility at a later date.
10. Inter se seniority based on the feeder cadre shall be the determining factor in the PGT cadre.


