1. That you have shown yourself on duty in the attendance register for the year 2023 & 2024 without passing any order and without any reasonable justification for which you failed to provide any documentary evidence. Thus, you remained absent from duty which adversely affected the working of the school
2. That you mark attendance in the register at 8:10 AM on 08.07.2024 and mentioned yourself on duty without passing any order in the order book. Further, you did not made any other staff member as incharge of the aforesaid school which created chaos in the school.
3. That you failed to manage the teaching faculty of the school by allocating classes in a logical manner as Shri Ravinder, DPE & Shri Bijender, DPE found sitting idle in the school *verandah* and no period were allocated to them for the class 6<sup>th</sup> to 8<sup>th</sup>. Further, Shri Ravinder, DPE was not allocated any classes from 9<sup>th</sup> to 12<sup>th</sup>.
4. That your behavior with subordinate staff is not good and you misbehaved with Smt Babita, Post Graduate Teacher by using abusive language and malign the designation of principal.
5. That you failed to comply with the orders of the higher authorities for which you were counseled many time but there is no improvement in your working.
6. That the financial work of the school such as HRMS/MIS/PFMS and maintenance of funds as well cash book is being made by your son i.e. Shri Kunal and thus, you allowed unauthorized access to a private person in the school record which is a lapse on your part.
7. That you drawn an amount of ₹2600/- from Government Treasury for office expenses of Government Primary School, Sohansra but did not paid this amount to aforesaid school.
8. That you being a principal were to take two periods in the school but you did not taught any class nor any period is mentioned in the time table of the school which is lapse on your part.
9. That you failed to allocate any subject to 12<sup>th</sup> class for 8<sup>th</sup> period.

The charged officer submitted his reply dated 31.05.2025 to the aforesaid charges and denied all the allegations levelled against him. He further requested to drop the charge sheet u/r-8. In the interest of justice, delinquent was granted an opportunity of personal hearing to explain his position on 22.07.2025.

Accordingly, the matter was considered and after going through the facts, record and circumstances of the case charge sheet is hereby filed with warning.

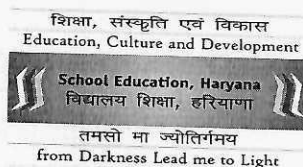

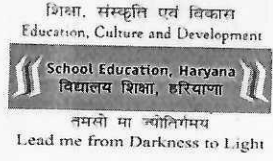
