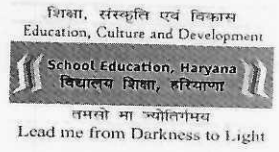



Whereas, Sh. Joginder, Clerk O/o District Education Officer, Sonipat was charge sheeted under rule-7 of Haryana Civil Services (Punishment and Appeal) Rules, 2016 vide order No. 5/17-2024 HRME-II (1) dated 08.02.2025/23.02.2025 wherein the following charges were levelled against him:-

**"That in Civil Writ Petition No. 35492 of 2019 filed by the petitioner before the Hon'ble Court, you failed to put up the file to the concerned dealing for further necessary action in which the Hon'ble High Court vide its order dated 26.04.2022 had granted the last opportunity to file the reply & when compliance of the said order was not done then the cost of Rs. 10,000/- was imposed to the pocket of W/DSE by the Hon'ble High Court vide its order dated 10.10.2022."**

Thereafter, the charged official submitted his reply to the said charge sheet vide letter dated 08.04.2025 and he denied all the allegations levelled against him.

The reply of the charged official was found un-satisfactory. Resultantly, Smt. Raj Bala, Assistant Director (Academic) was appointed as Inquiry Officer vide Order No. 5/17-2024 HRME-II (1) dated 09.05.2025. The inquiry officer submitted his report on 22.07.2025, wherein charges were not found to be proved against the charged official. The operative part of the findings/report is mentioned as under:-

**"Therefore, in light of the above finding, supporting documents and testimonials on record, I hold that Sh. Joginder Singh, Clerk is not guilty of the charges framed against him in the chargesheet dated 25.02.2025."**

Therefore, after taking a lenient view and considering the report of the Inquiry Officer, the charge sheet issued against Sh. Joginder, Clerk O/o District Education Officer, Sonipat is hereby dropped.

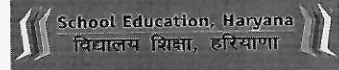




