Further, concerned District Education Officer is directed to allow the candidate to join at District Education office, if there is no vacancy at allotted school and report will be submit to Directorate along with vacancy available in the district of concerned subject for further temporary posting.





Whereas, Smt. Geeta had filed CWP No. 14167 of 2025 titled as Geeta V/s State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondents department to appoint the candidates belonging to the PwD (OH) category on the post of PGT Commerce in view of the fact that 1 post of PwD (VH) and 1 post of PwD (HH) has remained vacant in pursuance to the result declared by the Haryana Public Service Commission, Panchkula on 10.02.2025 of the posts which were advertised vide advertisement No. 20/2024 in view of the instructions dated 15.07.2014 issued by the Haryana Government. Further, prayed to direct the respondent department to appoint the petitioner on the post of PGT Commerce in view of the fact that the petitioner is at Sr. No. 3 of the merit list of PwD (OH) category in view of the instructions dated 15.07.2014 issued by the Haryana Government.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 16.05.2025 with following orders/direction:-

".....Notice of motion.

4. Mr. Harish Rathee, Senior Deputy Advocate General, Haryana, accepts notice on behalf of the respondents no. 1 and 2/State, and Mr. Kanwal Goyal, Advocate assisted by Ms. Sheena Dahiya, Advocate accepts notice on behalf of respondent no. 3/Commission. Learned State counsel submits that the representation, dated 21.04.2025, will be decided by respondent no.2/Director, Secondary Education Department by passing a speaking order in accordance with law within three months.

5. In view of the statement made, learned counsel for the petitioner has no objection to the petition being disposed of in terms thereof.

6. Ordered accordingly.

7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of 50,000 to the petitioner."

In compliance of above said order; the re-presentation dated 21.04.2025 of Smt. Geeta has been examined. The petitioner had applied for the post of Post Graduate Teacher (PGT), Commerce against the advertisement No. 20/2024 under Physically Handicapped (OH) and requested to interchange the 1 post PwD (VH) or 1 post of PwD (HH) which remained vacant into post for Loco-Motor disability in view of instruction dated 15.07.2024 and decision taken by the committee, Social Justice and Empowerment Department on 26.06.2018.

Whereas, the Directorate of School Education, Haryana, in order to fill up the vacant posts, had sent a requisition on 24.07.2024 to the Haryana Public Service Commission, Panchkula, requesting the Commission to initiate the process of recruitment for various subjects, which included 164 posts of (PGT) Commerce. Out of the said 164 posts, 6 posts were reserved for candidates belonging to the Persons with Disabilities (PwD) category, distributed as 2 posts for Visually Handicapped (VH), 2 posts for Orthopedically Handicapped (OH), 1 post for Hearing Handicapped (HH), and 1 post for Intellectual Disability/Multiple Disability (ID/MD).

Whereas, in pursuance of the requisition, the Haryana Public Service Commission, Panchkula, issued Advertisement No. 20/2024 inviting applications for the post of PGT Commerce against the above-stated vacancies. The petitioner, namely Smt. Geeta, also submitted her candidature under the PwD (OH) sub-category. After completion of the recruitment process, which included scrutiny of applications, conduct of written examination and interview, the Haryana Public Service Commission, Panchkula recommended the names of 149 eligible candidates for appointment to the post of PGT Commerce. However, the name of the petitioner did not find place in the list of recommended candidates, for the reason that the 2 posts earmarked for PwD (OH) sub-category had already been filled up by candidates higher in the order of merit. Subsequently, in



order to ensure that no post remains unutilized, the respondent department, after due deliberations with the competent authority, addressed a communication dated 21.08.2025 to the Haryana Public Service Commission, Panchkula, requesting the Commission to recommend suitable candidates against the carried forward vacancy if a suitable person with that disability is not available it may be filled by interchange among the four categories. Such request was made strictly in consonance with the Government instructions dated 25.04.2018, particularly Clause-M(ii) and (iii), which provide for the mechanism of interchanging vacancies among different sub-categories of PwD candidates in case posts remain unfilled in a particular sub-category. That upon consideration of the matter, Haryana Public Service Commission, Panchkula, being the sole recruiting agency vested with the statutory authority to recommend candidates, would carry out the process of interchanging of vacancies amongst the PwD categories.

In view of the facts mentioned above, the claim of Smt. Geeta is not tenable at this stage and liable for rejection.

I order accordingly.

Whereas, Smt. Bimla and others have filed CWP No. 13377 of 2025, titled Bimla and Others vs. State of Haryana & Others, before the Hon'ble Punjab and Haryana High Court, seeking issuance of a writ in the nature of mandamus for directing to the respondents to upgrade the minimum prescribed qualification for the post of the PGT(Computer Science) to as atleast Master degree in relevant subject, so in consonance with the minimum qualifications prescribed by the NCTE and on parity with the qualifications mentioned qua other subject for the post of PGT under the relevant rules.

The Hon'ble Punjab & Haryana High Court disposed of the said petition on dated 26.05.2025 with following orders:-

"....Notice of motion.

4. Ms. Tanushree Gupta, Deputy Advocate General, Haryana, accepts notice on behalf of the respondents/State and submits that the pending representation, dated 26.04.2025, will be decided by respondent no.2- Additional Chief Secretary, Department of School Education, by passing a speaking/reasoned order in accordance with law within a period of three months.

5. In view of the statement made, learned counsel for the petitioners has no objection to the petition being disposed of in terms thereof.

6. Ordered accordingly.

7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs.50, 000 to the petitioners."

In compliance with the aforesaid order, the representation dated 26.04.2025 submitted by Smt. Bimla and others have been examined. The petitioners have challenged the corrigendum issued by Haryana Public Service Commission, Panchkula on 25.04.2025. By virtue of this corrigendum, fresh applications were invited for the said post and eligibility

was extended even to those candidates who do not hold a Master's Degree in Computer Science or an equivalent qualification. The petitioners have argued that such relaxation of the minimum qualification is wholly arbitrary, contrary to the mandate of the National Council for Teacher Education (NCTE).

Whereas it is submitted that the State Government had advertised for the post of PGT Computer Science with following education qualification as specified in Haryana State Education Cadre (Group - B) Service Rules, 2012:-

- (i) **M.Sc. (Computer Science (Regular two year degree Course)/MCA (Regular Science three year Course)/B.E./B.Tech. Computer Science /Computer Engg./IT (Regular Course) with 55% marks from a recognized university.**
- (ii) **Matric with Hindi/Sanskrit or 10+2/B.A./M.A. with Hindi as one of the subject.**
- (iii) **Certificate of having qualified Haryana Teachers Eligibility Test (HTET)/School Teachers Eligibility Test (STET)**
- (iv) **Consistent good academic record.**

Further, it is relevant to note that the National Council for Teacher Education (hereinafter referred to as *NCTE*) was established under the provisions of the NCTE Act, 1993, with the mandate of regulating teacher education both at the Central as well as State levels. In exercise of its statutory powers, the NCTE had framed Regulations dated 12.11.2014 prescribing the minimum academic and professional qualifications required for recruitment of teachers in schools across the country. However, vide Memo No. NCTE-Leg1067/55/2020-Legal Section-IIQ/96359 dated 13.01.2021, the NCTE has categorically clarified that under its notification dated 12.11.2014, while minimum qualifications have been prescribed for teachers from the Pre-Primary level up to the Senior Secondary level, no specific qualification has been laid down for the post of PGT (Computer Science). It has further been clarified that the NCTE has prescribed minimum qualifications only for teachers at the Elementary and Secondary

levels, and no qualifications have been notified in respect of PGT (Computer Science). The natural corollary of this clarification is that, in the absence of any qualification prescribed by the NCTE for PGT (Computer Science), the field is left open for the State Government to frame appropriate rules governing eligibility criteria for appointment to the said post. Therefore, the Haryana State Education Cadre (Group-B) Service Rules, 2012, as amended and applicable, shall hold the field and shall be determinative of the qualifications for recruitment to the post of PGT (Computer Science).

Whereas, it is pertinent to mention that similarly situated candidates had also filed CWP No. 13697 of 2020, titled Kapil Kumar vs. State of Haryana and Others, challenging the academic qualification prescribed at Sr. No. 23 of Appendix-A of the Haryana State Education Cadre (Group-B) Service Rules, 2012, notified on 11th April 2012. In the said rules, candidates possessing B.E./B.Tech. in Computer Engineering/Computer Science were considered eligible for appointment as PGT (Computer Science), despite not possessing a Post Graduate Degree and B.Ed. The petitioners therein had prayed for quashing the said condition on the ground that it was contrary to the prescribed norms of NCTE. The aforesaid writ petition, along with connected matters, came up for hearing before the Hon'ble Court on 15.05.2025, wherein the Hon'ble Court modified its earlier interim orders dated 13.12.2023 and permitted those candidates to participate in the ongoing selection process who were found eligible and possessed the qualifications as laid down under Advertisement No. 26/23 and Advertisement No. 36/23, issued in consonance with the Haryana State Education Cadre (Group-B) Service Rules, 2012, for the post of PGT (Computer Science). The Hon'ble Court was pleased to pass the following directions:-

".....Since the counsel are present, no further notice is required to be given. So far as the interim order passed by the Court is concerned, we notice that the Court while passing order dated

13.12.2023 was not informed about the resolution dated 04.12.2023 of the NCTE as well as the letter dated 13.01.2021 of NCTE specifying that no qualifications have been laid down by the NCTE for PGT (Computer Science). Thus, the question whether for PGT (Computer Science), a candidate is required to possess Post Graduation in Computer Science alone as minimum qualification, needs to be finally adjudicated by this Court. However, we agree with the learned Senior Counsel that the candidates who fulfill the present qualifications under the Rules of 2012 for PGT (Computer Science), ought not be deprived participation.

14. We, therefore, modify our order dated 13.12.2023 to the extent allowing the participation of all the candidates who are eligible and possess qualifications as laid down in terms of advertisements No. Advt. No.26/23 and Advt. No.36/23.

15. Since none of the advertisements are under challenge before us, it is made clear that in terms of the theory of lis pendens, the ultimate selections which may be made, would be subject to the decision of these cases.”

Keeping in view the facts elaborated above, the judicial pronouncements referred to, and the documents placed on record, it is seen that the Haryana Public Service Commission, Panchkula vide corrigendum dated 25.04.2025, invited fresh applications for the post of PGT (Computer Science). By virtue of the said corrigendum, candidates possessing B.E./B.Tech. with a minimum of 55% marks from a recognized University/Institution have also been made eligible to apply. This action of the Commission has been taken strictly in consonance with the provisions of the Haryana State Education Cadre (Group-B) Service Rules, 2012. The corrigendum dated 25.04.2025 has further been modified by corrigendum dated 22.05.2025 which has been issued in consonance with the modified orders passed by the Hon'ble Punjab and Haryana High Court in CWP No. 13697 of 2020 (Kapil Kumar vs. State of Haryana and Others) and connected matters. The corrigendum dated 25.04.2025 has been replaced by corrigendum dated 22.05.2025 and the eligibility criteria prescribed through the corrigendum dated 22.05.2025 is neither arbitrary nor contrary

to the applicable statutory framework, rather they are fully justified and sustainable in law, having been upheld in principle by the Hon'ble Court. Consequently, the contention raised by the incumbents, namely Smt. Bimla and others, in their representation dated 26.04.2025 that the minimum qualification for the post of PGT (Computer Science) should mandatorily be upgraded to a Master's Degree in the relevant subject cannot be accepted. The demand made by the petitioners is contrary to the existing rules and judicial directions, and therefore lacks merit, justification, or legal enforceability.

Accordingly, in view of the discuss above, the representation submitted by Smt. Bimla and others dated 26.04.2025 stands considered in detail but is hereby rejected being devoid of merits.

It is ordered accordingly.


