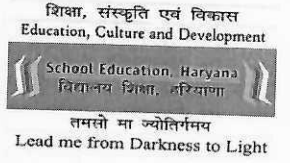



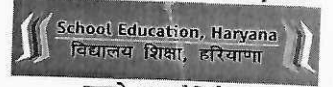

Permission is hereby granted to **Smt. Rajesh Kumari, PGT Hindi, Govt. Model Sanskriti Sr. Sec. School, Loharu (Bhiwani)** to change of option from fixed medical reimbursement to outdoor reimbursement for treatment of chronic diseases w.e.f. **04.04.2025** in terms of Haryana Government instructions issued time to time on the following conditions:-

1. That he/she will not be entitled to the fixed medical allowances w.e.f. the date of change of option i.e. 04.04.2025. The fixed medical allowance already received w.e.f. 04.04.2025 will have to be deposited in Government treasury.
2. The reimbursement will be made only for chronic diseases declared by Haryana Govt. from time to time.
3. That he/she will not be entitled for fixed medical allowance as long as he/she avails open medical allowance facility.
4. That the medical option has been changed since the pensioner/ employee/ employee's dependent family member is suffering from chronic disease. The certificate in this regard should be issued by the competent authority defined in the Rules.
5. The Medical Certificates is to be reviewed / renewed after a period of Five years or before date of its expiry whichever is earlier otherwise his/her medical option will be changed from open to fixed automatically.

**ORDER NO. 16/12-2023 PGT-II (6)**

**DATED, CHANDIGARH, THE 16.08.2025**

Whereas FIR No. 99 dated 07.04.2023 was registered against Sh. Umed Singh, PGT Hindi, Govt. Sr. Sec. School, MandholiKalan (Bhiwani) at Police Station Siwani, Bhiwani and the delinquent has been convicted by the Hon'ble Court of Sh. Ajay Prashar, Additional District and Session Judge, Bhiwani under section 6 of POCSO Act, 2012 and under section 363, 366 344, 376 (2) (n) of Indian Penal Code, 1860 to undergo rigorous imprisonment for 3 years U/S 363, 7 years U/S 366, 1 year U/S 344 IPC and 20 years U/S 6 of POCSO Act vide judgment/order dated 20.03.2025. Further, Sh. Umed Singh, PGT Hindi filed an appeal against his conviction in Hon'ble High Court vide CRA-D-623-2025 dated 25.04.2025. In appeal, till date no hearing has been held by Hon'ble High Court.

Whereas, section 06 of POCSO Act deals with Punishment for aggravated sexual assault and same is extracted as under:-

**1) Whoever commits aggravated penetrative sexual assault shall be punished with rigorous imprisonment for a term which shall not be less than twenty years, but which may extend to imprisonment for life, which shall mean imprisonment for the remainder of natural life of that person and shall also be liable to fine, or with death.**

**(2) The fine imposed under sub-section (1) shall be just and reasonable and paid to the victim to meet the medical expenses and rehabilitation of such victim.**

Section 363 IPC deals with the assault or punishment for kidnapping. The same is extracted below:-

*Vincent*



**Whoever kidnaps any person from India or from lawful guardianship, shall be punished with imprisonment of either description for a term which may extend to seven years, and shall also be liable to fine.**

Section 366 IPC deals with the assault for Kidnapping or abducting a woman to compel her for marriage or to cause her defilement etc. The same is extracted below:

**Whoever kidnaps or abducts any woman with intent that she may be compelled, or knowing it to be likely that she will be compelled, to marry any person against her will, or in order that she may be forced or seduced to illicit intercourse, or knowing it to be likely that she will be forced or seduced to illicit intercourse, shall be punished with imprisonment of either description for a term which may extend to ten years, and shall also be liable to fine;**

**And whoever, by means of criminal intimidation as defined in this Code or of abuse of authority or any other method of compulsion, induces any woman to go from any place with intent that she may be, or knowing that it is likely that she will be, forced or seduced to illicit intercourse with another person shall also be punishable as aforesaid.**

And section 344 IPC deals with Wrongful confinement for ten or more days. The same is extracted below:-

**Whoever wrongfully confines any person for ten days, or more, shall be punished with imprisonment of either description for a term which may extend to three years, and shall also be liable to fine.**

Whereas clause (a) of proviso to article 311(2) empowers the appointing authority to dismiss or reduce in rank or remove any person who is member of a civil service of the Union or an all India Service or a Civil Service of a State or holds a civil post under the Union or a State without a preliminary inquiry on the ground of conduct which has led to his conviction on a criminal charge.

Whereas delinquent is a teacher in a school and the offences for which he has been convicted are quite serious particularly considering the duties to be discharged by him. Sh. Umed Singh has been convicted by the Court for the aforesaid three serious offences which involves moral turpitude. A teacher with such a conduct is not desirable in a teaching job as the teacher is always a role model for the society, especially to the young minds to whom he is to teach. Therefore, a convicted teacher on offences mentioned above cannot be allowed to continue in service.

Hence, Sh. Umed Singh [208487], PGT Hindi (Suspended), Govt. Sr. Sec. School, MandholiKalan [547] (Bhiwani) is hereby dismissed w.e.f 17.07.2025 from his services by invoking the powers provided under Article 311 (2) (a) of the Constitution of India.


