Whereas, the names of the 49 selected candidates have been recommended by the Haryana Staff Selection Commission, Panchkula for appointment to the post of PGT **Sanskrit** vide recommendation No. Confd./01/10/2025/CA-11/58 dated 03.02.2025 against Advt. No. 4/2015 Category No. 16. While, recommending the name of the selected candidate, the HSSC, Panchkula had made an observation as under:-

“The selected candidates have not been medically examined and no special enquiry into their antecedents has been made. The documents pertaining to their Educational Qualification, age, Caste/Category and Universities as claimed by them in the application form may please be got checked/verified from the issuing authorities, before they are allowed to join their duties. A copy of the appointments letter issued to the candidates may also be endorsed to the Commission”.

Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 23.02.2025. After completing the due process, appointment letters were issued to 36 eligible candidates who were appeared before document verification committee and directed to join within 15 days at allotted station. But, the following 2 candidates not joined their duties and requested for extension for joining. On their request three months extension till 05.07.2025 has been granted to these candidates. However, they did not join their duties during extension period and requested for further three months extension.

Keeping in view of the above, I have come to the conclusion that the above mentioned candidates are not willing to serve as PGT Sanskrit as they have again failed to join their duties after giving proper opportunities and requested for further extension.

In view of the above, it has been decided to cancel your candidature for the post of PGT Sanskrit. However, before cancellation of

your candidature, a final opportunity is granted to you to join their duties within 15 days (till 18.09.2025) otherwise your appointment/candidature will be cancelled. No further opportunity will be granted.
