1. These promotion are without prejudice to the right of their seniors. In case any claim by any senior is decided/reverted at any stage in future, they will be reverted to their original post from which they are being promoted.
2. If any, disciplinary proceeding under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rule, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
