6. As per Rule 21(2) of HCS (Leave) Rules, 2016, during the period of extraordinary leave, no leave salary except house rent allowance upto one hundred and eighty days shall be admissible.
7. In terms of Note 2 below Rule 26 of HCS (Leave) Rules, 2016, the entire period of extraordinary leave (without pay) shall not be treated as qualifying service for any purposes.
8. As per note below Rule 72 ibid, the probation period shall be extended by the period of leave availed during the probation.


