#### Terms and Conditions:-

- This promotion is subject to final outcome of CWP No. 35929 of 2019 titled as Rajbir Singh Vs State of Haryana & ors and CWP No. 8791 of 2020 titled as Maha Singh Sindhu Vs State of Haryana & ors.
- 2. If any, disciplinary proceeding under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
- 3. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the

eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.

- 4. If any discrepancy regarding not fulfilling the essential requirements as prescribed in the Haryana State Education (Group-A) Rules, 1998, the said incumbent(s) shall be reverted without issuing any notice.
- 5. The inter-se-seniority of the promote(s) shall be subject to the claim of their seniors, who have not been promoted in these orders due to various reasons and for whom the posts have been kept reserved.
- 6. If any official is found senior to these officials at any stage due to re-fixation of seniority in feeder cadre, they shall be reverted without giving any notice.
- 7. The promote (s) will remain on probation for a period of one year as per Rule-27 of HCS(General) Rules, 2016 which can be extended if their services are not found satisfactory.

This order is subject to final outcome of case of the Apex Court in the case of Jarnail Singh and others Vs Lachhmi Narain Gupta and Ors (I), (2018) 10 SCC 396 & (II), 2022(10) SCC 595 and Judgement of the Punjab & Haryana High Court order in CWP No. 22475 of 2018 (Same Singh & others Vs State of Haryana & others).
- 9. These promotions are subject to the condition that if anything adverse regarding their integrity in anyone of their non-available of ACRs mentioned against their name is found doubtful they will be reverted without giving any notice.

If they are not willing to accept this offer of promotion as HES-I on the above terms and conditions, he/she should submit his/her representation regarding forgo of promotion to the Directorate within seven days positively.
