



- 1. His appointment is subject to the condition that concerned District Education Officers may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.
- 2. He is also directed to participate in next online transfer drive for taking permanent Station.

TERMS & CONDITIONS:-

- 1. His appointment is against a purely temporary post which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. His services can be terminated without any notice, whenever there is no vacancy against which they can be retained.

- 5. In case he is unmarried, he will has to furnish a declaration to the Head of the Department that he has not taken any dowry after marriage. - 14. His services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Harvana Government as per Finance Department's notification dated 28.10.2005.



15. That if he got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be false or forged or fraudulent, he would be liable for termination of his services without any notice besides such criminal action he may be taken as prescribed in the Indian Penal Code or any other Law enforce.
