Efficient and timely condemnation and disposal are essential for sound financial management and optimal resource allocation within the State.

incomplete and decisive action to expedite the process of condemnation and disposal of surplus and unserviceable stores within their respective purviews. The following actions are

to be given top priority:

Initiate condemnation proceedings promptly: Send an indent to the Directorate General of Supplies & Disposals (DGS&D) or the Concerned eputy Commissioner to get the surplus/unserviceable stores condemned as Government policy/instructions.

I tain necessary approvals: Ensure all required approvals from the Competent Authority are secured before proceeding with condemnation and disposal of surplus/unserviceable stores.
