Whereas, the names of the 20 selected candidates have been recommended by the Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Political Science** vide recommendation No. RG-15/2024/2898 dated 25.07.2025 against Advt. No. 32/2024. While, recommending the name of the selected candidate, the HSSC, Panchkula had made an observation as under:-

"The Commission has interviewed and recommending the above candidate on the basis of the photocopies of documents submitted by them alongwith their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission."

Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 07.08.2025, but Sh. Sandeep S/o Sh. Satbir Singh bearing Roll No. 8498 remained absent during the verification of documents.

Keeping in view of the above, I have come to the conclusion that Sh. Sandeep S/o Sh. Satbir Singh is not willing to serve as PGT Political Science as you have failed to appear before Document Verification Committee for verification of their documents.

In view of the above, it has been decided to cancel your candidature for the post of PGT Political Science. However, before cancellation of your candidature, a notice is hereby served upon you, as to why your candidature be not cancelled. Reply, if any, you want to file in response to this notice may be filed in the office of Director Secondary Education, Haryana, Panchkula and through E-mail i.e. dsepgtl@gmail.com not later than 15 days from the date of this notice. In case, you fail to respond to the notice within a stipulated period, it shall

be presumed that you have nothing to say/submit in this regard and the candidature will be cancelled.
