SHOW CAUSE NOTICE

Dated, Panchkula:

Whereas Unison International School, Village Dhamala, Pinjore-Baddi Highway, Pinjore, Panchkula run by the Managing Committee, Unison International Society, was granted permanent recognition upto 12th level vide order no. PSR052024471 dated 05.08.2024 by the Director Secondary Education Haryana, Panchkula.

Whereas, a surprise inspection was conducted on 06.08.2025 in Unison International School, Village Dhamala, Pinjore-Baddi Highway, Pinjore, Panchkula under the Chairmanship of Veena Singh Assistant Director Admn. o/o Directorate of Secondary Education, Haryana, Panchkula.

The purpose of the inspection was to verify the compliance status in regard to the conditions mentioned in the recognition granted to the said school vide order no. PSR052024471 dated 05.08.2024 following observations were made in the report:-

It is evident that Unison International School, Village Damla, Near Pinjore- Baddi Highway, Distt. Panchkula fulfils all land and building norms except the availability of a ramp for accessing all floors in the school building, which is mandatory under the building norms of the Haryana School Education Rules, 2003. The inspection report is therefore submitted for kind information and further necessary action.

Whereas the school was granted recognition on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

Whereas Rule 30 of Haryana School Education, 2003 provides for the conditions for grant of the recognition to private schools of the State of Haryana. The operative part of Rule 30 of Haryana School Education Rules, 2003 is reproduced here as under:-

30. (1) No private school shall be recognized, or continue to be recognized, by the appropriate authority unless the school fulfils the following conditions, namely:

- (a) xxxxx
- (b) Minimum norms for land and buildings
 - (i) xxxxxxxx
 - (ii) Building-
 - (a) xxxxxxxx
 - (b) xxxxxx;
 - (c) xxxxxxxx
 - (d) xxxxxxxx

- (g) *Every school shall provide ramp at plinth level.*
(h) *the school building having more than one storey shall provide one ramp and one staircase of at least 6' width: Provided that the school running before commencement of the Haryana School Education Rules, 2003, the norms for stairs and ramp shall be as under: —*

Stair 4.6 feet in width. If the school do not provide ramp than they shall arrange the classes of handicapped students at the ground floor.

Ramp: 6 feet in width. If the school do not provide ramp than they shall arrange the classes of handicapped students at the ground floor.

Note:- *The appropriate authority designated in rule 34 shall be competent to relax the norms of land and building upto ten percent and also allow minor variations which would otherwise not affect health and safety of students and staff.**

In view of enquiry report dated 05.08.2025 it appears that school is being run in violation of rule 30 (i) (g) & (h) of Haryana School Education Rules, 2003.

Whereas Rule 42 of the Haryana School Education Rules, 2003 provides that the appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued there under to the managing committee either directly or through Principal/ Head of the institution.

Therefore, a show cause notice is being issued to the management of the said school as to why the recognition granted to the school be not withdrawn under Rule 42 of the Haryana School Education Rules, 2003.

The Management of the school, if wants to submit any reply should submit to undersigned within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules.
