Dhingra (Retd.), who is presently empanelled as an Inquiry Officer for conducting departmental inquiries under Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016, shall cease to be on the panel with effect from 02.10.2025, as he will be attaining the age of 70 years on that date.

This decision has been taken in accordance with the instructions issued by the Vigilance Department vide letter dated 15.03.2022, which prescribe an upper age limit of 70 years for empanelled Inquiry Officers.
