That school has failed to submit documents in support of its application for NOC in course of inspection. Hence, the NOC certificate cannot be issued for non fulfillment of guideline dated 14.08.2015 & 22.09.2016

Therefore, your application has not been found in conformity with the departmental guidelines. Accordingly, the claim of your school for grant of Minority Status stands rejected.



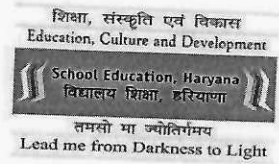



Whereas, Radha Krishan Senior Secondary School, Near Green Market Modal Town, Kaithal was granted permanent recognition for classes 11th to 12th vide order no. KW25/73-2014 PS(2) dated 31.03.2017 by the Director Secondary Education, Haryana, Panchkula.

Whereas a complaint was received against the Radha Krishan Senior Secondary School, Near Green Market Modal Town, Kaithal from Deputy Commissioner, Kaithal.

Whereas the District Education Officer, Kaithal submitted her report vide memo number G1/25/1721-26 dated 21.04.2025. In the report it was submitted that the school management is using the books of private publishers instead of NCERT books in school. That the Radha Krishan Senior Secondary School, Near Green Market Modal Town, Kaithal was found open on 10.04.2025 despite the fact that the gazette holiday was declared on dated 10.04.2025 by the Govt. of Haryana.

Whereas the Director Secondary Education Haryana vide its memo no. 8/27-2020 PS (2) dated 06-05-2021 has issued directions for prescribing only NCERT Books in all private recognized schools in the state of Haryana. Furthermore Department of Education has also amended the Haryana School Education Rules 2003 vide notification dated 08-12-2021. Amended Rule 158 (6) states as under:-

***"No student shall be compelled to purchase books, note books, workbooks stationary, shoes, socks, uniform etc only from a shop recommended by the recognized school."***

Whereas the said school has violated the above mentioned statutory rules by prescribing books other than NCERT/ Private publishers books and by compelling the students to buy books etc from a shop recommended by the school management.
