On the recommendation of Haryana Public Service Commission, Panchkula conveyed vide their Memo No. HSSC/Confid./Recomm./01/39/2025/CA-11/299 dated 12.08.2025, the Governor of Haryana is pleased to appoint the following candidate as Post Graduate Teacher **Biology** (HES-II) (Rest of Haryana cadre) against Advt. No. 4/2015 in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600 – 1,51,100/- plus usual allowances as admissible from time to time. He is directed to join at the place of posting as mentioned against his name as under:-

Terms and conditions:-

1. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. The candidate shall have to take an oath of allegiance to the Constitution of India.
3. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
4. The candidate shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
5. The candidate shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.

6. In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
7. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate from issuing authority. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is found false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. The candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter educational qualification certificates be got verified from the issuing authority within 03 months. If in the verification it reveals that any certificate is found false then your appointment will be cancelled without any notice.
9. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
10. The candidate shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
11. If at any time during the course of temporary appointment, the candidate desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
12. No TA/DA will be admissible to the candidate for joining as PGT.
13. If the candidate gets an appointment as PGT on the basis of furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, the candidate would be liable for termination of service without any notice.
14. This appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
15. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in the self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provision of Indian Penal Code (IPC) etc as deemed fit.

Servants as per instructions issued from time to time.

His appointment in the O/o Director Secondary Education Haryana, Panchkula will be on the following terms and conditions:-

1. His appointment is against purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. As such, as and when there will be no vacancy against which he could continue to officiate in the Directorate of School Education Haryana, he will be repatriated to his parent office. It is, thus made clear to him that at present he has been offered temporary post.
2. He will be required to take the prescribed oath of allegiance to the Constitution of India.
3. In case he is unmarried, he shall have to furnish a declaration to the effect that he will not have more than one living spouse.
4. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the prosecution of higher studies.

6. 7. He will be on probation for a period of one year from the date of joining. If his work and conduct is not found satisfactory, he will be repatriated to his parent cadre without giving any notice to him.

8. In case he is married, he would have only one living spouse, if he has more than one living spouse, he should justify for that.
9. He will be given seniority as per Rule 11 of the Haryana Education Directorate (State Service Class-III), Rules 1974 as amended from time to time. He will be assigned seniority from the date he joins in the Head Office and will be placed at the tale-end of the employees already appointed in the Head Office.
10. He will have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) if not qualified earlier. He will not be entitled to earn any increment in his pay scale till she qualifies the said test failing which the service of such employee shall be dispensed with.
11. His services will be governed under the New Pension Scheme of the Haryana, Government.
12. No T.A/D.A. will be allowed to him for joining this post.

If he is willing to accept the offer made on the above mentioned conditions, he may get himself relieved and report for duty to the O/o Director Secondary Education Haryana, Panchkula within a period of 15 days from the date of issue of this letter.

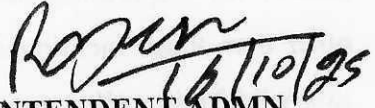

Whereas, the names of the 43 selected candidates have been recommended by the Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Sanskrit (Mewat Cadre)** vide recommendation No. RG-15/2024/14658 dated 07.02.2025 against Advt. No. 34/2024. While, recommending the name of the selected candidate, the HSSC, Panchkula had made an observation as under:-

"The Commission has interviewed and recommended the above candidates on the basis of the photocopies of documents submitted by them alongwith their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfill all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission."

Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 23.02.2025, but Smt. Priyanka D/o Sh. Parmanand bearing Roll No. 3592 remained absent during the verification of documents.

Thereafter, opportunity was again given to Smt. Priyanka for verification of documents by the department on 08.05.2025 through public notice dated 02.05.2025, but she was again failed to appear before document verification committee.

Keeping in view of the above, I have come to the conclusion that Smt. Priyanka is not willing to serve as PGT Sanskrit because she has failed to appear before Document Verification Committee for verification of her documents despite giving appropriate opportunities.

In view of the above, it has been decided to cancel candidature of the candidate namely Smt. Priyanka for the post of PGT Sanskrit (Mewat Cadre). However, before cancellation of her candidature, a notice is hereby served to her as to why the candidature be not cancelled. Reply, if any, she want to file in response to this notice may be filed in the office of Director Secondary Education, Haryana, Panchkula and through E-mail i.e. dsepgt1@gmail.com not later than 15 days from the date of this notice. In case, she fail to respond

to the notice within a stipulated period, it shall be presumed that she has nothing to say/submit in this regard and the candidature will be cancelled.

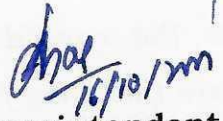

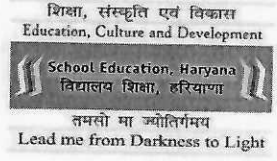
